



CHAPTER 119

An Act to place *École St. Édouard à Beauport* under the government and control of the school commissioners of the parish of Beauport

[Assented to, the 4th of April, 1929]

WHEREAS the school commissioners of the parish of Beauport, have, by their petition, represented:

That by deed passed before Joseph Désiré Marcoux, notary public, at Beauport, on the 13th of October, 1906, a gift *inter vivos* was made by Joseph Edouard Bédard, advocate, and Dame Adéline Bélanger, his wife, to the Rev. Louis Anselme Déziel, parish priest of the said parish of Beauport, to Jules Bélanger, mayor of the said parish, and to Edmond Giroux, chairman of the school commissioners, of the same parish, accepting thereof, in their respective official capacity, for themselves and for their successors in office, of an immoveable known and designated as No. 468-A-1 of the official cadastre and book of reference of the parish of Beauport;

That the said immoveable constitutes and includes the school known and designated under the name of *École St. Édouard à Beauport*;

That the said donees were incorporated under the name of *Les Syndics de l'École St. Édouard à Beauport*, to hold the said immoveable in trust, for the purposes of a primary school for the young boys of the parish of Beauport, as appears by act of the Legislature, 7 Edward VII, chapter 115;

That, in the said deed of gift, it was provided by the donors that the said school could be placed by the said donees under the government of the school commissioners of the parish of Beauport by such agreement as might be deemed fit;

That, by a deed made on the 19th of March, 1907, before J. D. Marcoux, notary public, the said trustees of the *École St. Édouard de Beauport* and the school commissioners of the parish of Beauport entered into a contract, under the terms of which the said commissioners hand over to the said trustees the necessary funds for the maintenance of said immoveable, its furnishing, the salary of the Brothers teaching in the said school, and all other expenses required for the keeping and proper working of the said school, within sixty days from the demand made in writing upon the commissioners by the trustees;

That it is in the interest of the ratepayers that the commissioners should control expenditure, and take the said school under their direction;

And whereas it is expedient to grant the prayer to that effect, contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

7 Ed. VII, c. 115, s. 5, replaced. **1.** Section 5 of the act 7 Edward VII, chapter 115, is replaced by the following:

Direction of school. **“5.** In order that the said school may participate in the advantages granted by the law to public schools in this Province, the said trustees may, if they deem it advisable, place the said school under the direction and control of the Catholic school commission having jurisdiction over the territory in which the said school is built, for such period of time as may be deemed advisable.

Idem. During such period, the school commissioners of the parish of Beauport shall alone have the direction of the said school. They shall maintain and preserve the said immoveable and return it to the trustees, at the expiration of the time stipulated, in the same state as when they received it. No changes nor major repairs in the said immoveable may be made by them without the express consent in writing of all the trustees.

Idem. The school commissioners of the parish of Beauport must entrust the said school, for the said period and in accordance with the purposes stated in this act, to a religious congregation chosen by the trustees.

Costs of maintenance, etc. All costs of maintenance, upkeep, teaching, furnishing and generally all pecuniary liabilities incurred with regard to the said school, during the time stipulated, shall be borne by the school commissioners of the parish of Beauport and shall not affect the above-described immoveable.

During the stipulated period, the trustees may make any comment, complaint and suggestion to the commissioners respecting the teaching, hygiene and morals, which they may deem expedient, and they may visit the said school at any time.”
