



## CHAPTER 67

### An Act to amend the Industrial Establishments Act

*Assented to, the 15th of March, 1928]*

**H**IS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** The Industrial Establishments Act (Revised Statutes, 1925, chapter 182) is amended by inserting therein, after section 18 thereof, the following division and sections: R. S., c. 182, ss. 18a-18f, added.

#### "DIVISION Va

##### "NEW OR USED STEAM BOILERS

"**18a.** The examiners appointed under section 3 of the Stationary Engineers' Act (Chap. 184) shall, without prejudice to any other obligation imposed upon them by such act respecting the examination of stationary engineers, supervise the construction in this Province of steam boilers and inspect them at the place of manufacture before they are put on sale. Duties of examiners as to steam boilers.

"**18b.** Every steam boiler constructed in another province or abroad and intended to be put into operation in the Province of Quebec shall be registered at the examiners' general office; and, for such purpose, the specifications and blue prints of every steam boiler or other apparatus for containing gas, air or a liquid under pressure, as well as all accessories thereof, steam-gauges, safety valves, level-gauges, exhaust valves and others, connecting with said boilers or apparatus, shall be submitted to the approval of the examiners. Registration of certain steam boilers, etc.

The manufacturers or contractors of such boilers constructed in another province or abroad shall supply a specification sheet to be supplied.

cification sheet supported by an affidavit establishing the quality of the material and labour mentioned in the plans and specifications transmitted to the examiners.

Copy supplied and transmitted.

**"18c.** A triplicate copy duly signed by the examiner mentioning the registration number and the plans and specifications of each steam boiler and its accessories shall be supplied to the board of examiners. Such copy shall be transmitted by the examiners to the boiler manufacturers.

Certificate for used boilers.

**"18d.** No used steam boiler, whether repaired or not, may be again commercially dealt with for the purpose of being again used as a steam boiler, before its owner has obtained from the board of examiners a certificate determining the pressure to which such boiler may be subjected without danger.

Canadian Interprovincial Standard to serve as guide.

**"18e.** The interprovincial code, known under the name of "Canadian Interprovincial Standard", in force in the other provinces of Canada, shall serve as a guide for:

1. The construction of steam boilers and the classification of their accessories;

2. The elaboration of forms and documents necessary for the proper administration of the law, its uniform application and the technical direction of examiners in the exercise of their duties.

Carrying out of act.

**"18f.** The Lieutenant-Governor in Council may enact regulations for the carrying out of this act.

Tariff of fees.

He may also enact a tariff of fees for the examination of new or used steam boilers, and their accessories."

Coming into force.

**2.** This act shall come into force on the day of its sanction.
