



CHAPTER 118

An Act to change the name of The General Administration Society (*La Société d'Administration Générale*)

[Assented to, the 15th of March, 1928]

WHEREAS The General Administration Society, a com- Preamble.
pany having its head office in Montreal, has, by its petition, represented that it was incorporated by the act 2 Edward VII, chapter 69, as amended by the act 2 George V, chapter 103, and that it would be in its best interest, for the administration and development of its affairs, that its name be changed to that of "Administration and Trust Company", in English, and *Société d'Administration et de Fiducie*, in French;

Whereas it is expedient to grant the prayer contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The preamble of the act 2 Edward VII, chapter 69, 2 Ed. VII, c. 69, preamble replaced.

"Whereas the Honourable Damien Rolland, J. O. Gravel, Joseph Robillard, Emmanuel P. Lachapelle, M.D., the Honourable Charles C. de Lorimier, the Honourable J. S. C. Würtele, the Honourable J. Alderic Ouimet, Martial Chevalier and Albert E. de Lorimier, have, by their petition, prayed to be incorporated, under the name of "Administration and Trust Company", in English, and *Société d'Administration et de Fiducie*, in French, for the purpose of executing trusts and administering estates and other property, of receiving deposits, of acting as executors, guardians, liquidators and general financial agents, and whereas it is expedient to grant their prayer."

2 Geo.V, c. 103, preamble replaced. Preamble. **2.** The preamble of the act 2 George V, chapter 103, is replaced by the following:

“Whereas the “Administration and Trust Company”, in English, and *Société d'Administration et de Fiducie*, in French, incorporated by the act 2 Edward VII, chapter 69, has, by its petition, prayed that said act be amended by changing its name and granting it new and additional powers.”

2 Ed. VII, c. 69, s. 1, replaced. **3.** Section 1 of the act 2 Edward VII, chapter 69, as replaced by the act 2 George V, chapter 103, is again replaced by the following:

Incorporation. **1.** The several persons hereinbefore named, and such others as are or may hereafter become shareholders in the company, shall be and they are hereby constituted a body corporate, under the name of *Société d'Administration et de Fiducie*, in French, and “Administration and Trust Company”, in English, and, by that name, may make and receive all deeds, conveyances, transfers, assignments and contracts necessary to carry the provisions of this act into effect, and to promote the intentions and purposes of the said corporation.”

Name.

Coming into force. **4.** This act shall come into force on the day of its sanction.
