



## CHAPTER 142

An Act to ratify certain resolutions and contracts made between the Murray Bay Paper Company, Limited, and the school commissioners for the municipality of the parish of St. Etienne de la Malbaie and the municipal council of the parish of St. Etienne de la Malbaie

*[Assented to, the 22nd of March, 1928]*

**W**HEREAS the municipal council of the parish of St. Etienne de la Malbaie, county of Charlevoix, on the 19th day of September, 1927, adopted a resolution to determine the total amount of the municipal valuation and of the other municipal taxes on all the taxable property of the Murray Bay Paper Company, Limited, necessary for the operation of its industry, to the exclusion of all residential properties, and of all those parts of its immoveables already occupied by the pulp plant operated hitherto by Donohue Brothers, Limited, at not more than two hundred and fifty dollars for the first year, and not more than one thousand dollars per annum for a period of ten years, to be computed from the 1st of May, 1928; Preamble.

Whereas in accordance with such resolution and to give effect thereto, a contract has been made before L. A. Bouliane, N.P., between the Murray Bay Paper Company, Limited, and the corporation of the parish of St. Etienne de la Malbaie, on the 8th day of November, 1927, confirming all the clauses and conditions mentioned in the above resolution;

Whereas the school commissioners of the municipality of the parish of St. Etienne de la Malbaie, in the county of Charlevoix, did, on the 22nd day of September, 1927, adopt a resolution to fix the total amount of the school valuation and other school taxes on all the taxable properties of the Murray Bay Paper Company, Limited, necessary for the operation of its industry, exclusive of all residential properties and of all those parts of its immoveables already

occupied by the pulp plant hitherto operated by Donohue Brothers, Limited, at not more than two hundred and fifty dollars for the first year, and not more than one thousand dollars per annum for a period of ten years, to be computed from the 1st of May, 1928;

Whereas in accordance with such resolution, and to give effect thereto, a contract was entered into before L. A. Bouliane, N.P., between the Murray Bay Paper Company, Limited, and the school commissioners for the municipality of the parish of St. Etienne de la Malbaie, on the 8th day of November, 1927, confirming all the clauses and conditions mentioned in the above resolution;

Whereas the said resolutions and contracts mention that they shall not be valid until after their ratification and confirmation by the Legislature;

Whereas the Murray Bay Paper Company, Limited, desiring to take advantage of the offers mentioned in the above cited resolutions and contracts, wishes to obtain ratification of such resolutions and contracts by an act of the Quebec Legislature;

Whereas on the 1st of October, 1927, the Murray Bay Paper Company, Limited, passed a resolution, authorizing its officers to take all necessary proceedings to obtain such ratification;

Whereas the company prays for the confirmation and ratification of the said resolutions and said contracts; and

Whereas it is expedient to grant such prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Resolutions, etc., ratified. **1.** Are hereby confirmed and ratified for all legal purposes, the resolutions and contracts, described as follows:

*a.* A resolution passed by the municipal council of the parish of St. Etienne de la Malbaie, county of Charlevoix, at its meeting held on the 19th day of September, 1927, by which the municipal corporation determined the total amount of the municipal valuation and of the other municipal taxes on all the taxable property of the Murray Bay Paper Company, Limited, necessary for the operation of its industry, to the exclusion of all residential properties, and of all those parts of its immoveables already occupied by the pulp mill operated hitherto by Donohue Brothers, Limited, at not more than two hundred and fifty dollars for the first year, and not more than one thousand dollars per annum for a period of ten years, to be computed from the 1st of May, 1928;

*b.* A contract between the corporation of the parish of

St. Etienne de la Malbaie, county of Charlevoix, and the Murray Bay Paper Company, Limited, made before L. A. Bouliane, N. P., on the 8th day of November, 1927, giving effect to the above-mentioned resolution;

c. A resolution adopted by the school commissioners of the municipality of the parish of St. Etienne de la Malbaie, at their meeting held on the 22nd day of September, 1927, by which the commissioners fixed the total amount of the school valuation and other school taxes on all the taxable properties of the Murray Bay Paper Company, Limited, necessary for the operation of its industry, exclusive of all residential properties and of all those parts of its immoveables already occupied by the pulp plant, hitherto operated by Donohue Brothers, Limited, at not more than two hundred and fifty dollars for the first year, and not more than one thousand dollars per annum for a period of ten years, to be computed from the 1st of May, 1928;

d. A contract entered into between the school commission for the municipality of the parish of St. Etienne de la Malbaie, county of Charlevoix, and the Murray Bay Paper Company, Limited, before L. A. Bouliane, N. P., on the 8th day of November, 1927, giving effect to the above resolution.

**2.** The provisions of this act shall apply to the Murray Provisions Bay Company, Limited, under whatever name it may applicable. hereafter be known, as well as to its successors and assigns.

**3.** This act shall come into force on the day of its sanc- Coming into force.
