



## CHAPTER 145

An Act to cancel the substitution created by a deed of gift by Stanislas Donatien Joubert to his children, on the 20th of April, 1921

[Assented to, the 22nd of March, 1928]

**W**HEREAS Stanislas Donatien Joubert, manufacturer, Preamble.  
of the town of Outremont, district of Montreal;  
Dame Marie Charlotte Carpentier, of the same place, wife  
common as to property of the said Stanislas Donatien  
Joubert, and by the latter duly authorized for the purpose  
hereof; Paul E. Joubert, Hector Joubert, Dr. Louis de Gon-  
zague Joubert, Dame Marie Berthe Joubert, wife separate  
as to property of Dr. T. N. Larseneur, and by the latter duly  
authorized for the purpose hereof; Dame Jeanne Joubert,  
wife separate as to property of Paul Galibert, manufacturer,  
and by the latter duly authorized; J. Arthur Bacon, mer-  
chant, in his capacity of curator to the substitution created  
by the deed of gift hereafter mentioned, all of the same  
place, have, by their petition, represented:

That by deed passed at Montreal, on the 20th of April, 1921, under number 6218 of the minutes of Mtre. J. A. Savignac, N. P., Stanislas Donatien Joubert made a gift *inter vivos*, in equal shares, to each of his above-mentioned children, Paul E. Joubert, Hector Joubert, Louis de Gon-  
zague Joubert, Dame Marie Berthe Joubert and Dame  
Jeanne Joubert, with substitution to his grandchildren and  
great-grandchildren, of five thousand and ten shares of one  
hundred dollars each of the capital stock of the company  
*Lamontagne Limitée*;

That Dame Marie Charlotte Carpentier, above mentioned,  
intervened in the said deed and declared that she concurred  
therein as far as she was obliged and concerned;

That at the time of the said gift the aforesaid Stanislas  
Donatien Joubert held the majority of the shares of  
the company *Lamontagne Limitée*;

That the petitioners are, in fact, the only persons interested in the said company of *Lamontagne Limitée*, only one hundred shares being held by other shareholders;

That the substitution created by the donor hinders the development of the company *Lamontagne Limitée* by preventing the donees from transferring, giving in exchange or generally negotiating, as required, the shares so given to them;

That a meeting of the family council, held for the purpose, approved of the passing of an act to cancel such substitution, as appears by the judgment of the competent court;

Whereas they have prayed for the passing of such an act;

And whereas it is expedient to grant their prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Substitution cancelled.

**1.** The substitution created by the deed of gift by Stanislas Donatien Joubert to his children, passed at Montreal on the 20th of April, 1921, under number 6218 of the minutes of Mtre. J. A. Savignac, notary, is cancelled for all legal purposes, and the donees may alienate the shares mentioned in such deed notwithstanding any prohibition to alienate contained therein, or other hindrance.

Coming into force.

**2.** This act shall come into force on the day of its sanction.
