



## CHAPTER 48

An Act to amend the Revised Statutes, 1925, respecting  
the establishment of Peace Offices at Ville-Marie  
and at Rouyn

*[Assented to, the 1st of April, 1927]*

**HIS MAJESTY**, with the advice and consent of the R. S., c. 145:  
Legislative Council and of the Legislative Assembly 1926, cc. 14,  
of Quebec, enacts as follows: 51.

**1.** Division VI of Part I of chapter 145 of the Revised R. S., c. 145,  
Statutes, 1925, (Courts of Justice Act), comprising sections ss. 143-146,  
143 to 146 of the said chapter, is replaced by the follow- replaced.  
ing division and sections:

### "DIVISION VI

"PEACE OFFICES IN THE JUDICIAL DISTRICT OF PONTIAC, AT  
VILLE-MARIE AND ROUYN

"**143.** The Lieutenant-Governor may by proclamation Peace offices  
order the establishment of Peace Offices, in and for the at Ville-

"**144.** The Lieutenant-Governor in Council shall ap- Appoint-  
point, during pleasure, persons with sufficient capacity and ment of

The remuneration of each of such Deputy-Clerks of the Remunera-  
Peace, whether by fees or salary, shall be subject to the pro- tion.  
visions of sections 11 to 15 of chapter 155 of the Revised  
Statutes, 1925, (Officers of Justice Salary Act).

Additional  
employees.

The Lieutenant-Governor in Council may also appoint the additional employees that he may deem expedient to assist such deputies in the carrying out of their duties, and may fix, in the same way, the salary of such employees.

Powers of  
Deputy-  
Clerks.

**"145.** Each Deputy-Clerk of the Peace appointed under the foregoing section 144 shall have, with respect to the accounts which he has to render and to the matters and things with which he is entrusted in the carrying out of his functions, the same powers, duties and obligations as the Clerk of the Peace, at the chief-place.

Idem.

He shall have the custody of all the records of the office, with the exception of those which relate to matters appertaining to the courts of superior criminal jurisdiction which must be transmitted by him to the Clerk of the Peace at the chief-place of the district".

Expenses.

**"146.** The expenses to be incurred in the carrying out of this division and not otherwise provided for shall be paid out of the consolidated revenue fund."
