



CHAPTER 61

An Act to amend the Accountants' Act

[Assented to, the 1st of April, 1927]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. Section 2 of the Accountants' Act (Revised Statutes, R. S., c. 222, 1925, chapter 222) is amended: s. 2, am. **1**

a. By replacing the words: "Accountants' Association", in the seventh line of the first paragraph thereof, by the words: "Corporation of Public Accountants of the Province of Quebec";

b. By replacing the second paragraph thereof by the following:

"The head office of the corporation shall be at Mont-Head office. real".

2. Section 3 of the said act is amended by replacing R. S., c. 222, the word: "association", in the fifth and sixth lines of sub-paragraph 3 thereof, by the word: "corporation". s. 3, am.

3. Section 5 of the said act is amended:

Id., s. 5, am.

a. By striking out the words: "and except as to examinations and matters relating thereto", in the first and second lines of the first paragraph thereof;

b. By inserting therein, after the word: "respecting", in the third line of the first paragraph thereof, the following words: "the examinations";

c. By replacing the second paragraph thereof by the following paragraph:

"The Administrative Council, acting for and in the name of the corporation, is authorized, from and after the 1st of February, 1927, to enter into any contract or arrangement it may see fit with recognized universities, as to educational Authoriza-

matters and the qualifications required for admission as a member of the corporation.

4. Section 6 of the said act is repealed.

5. Section 7 of the said act is amended:

a. By replacing the words: "a board of fourteen directors", in the second line of the first paragraph thereof, by the words: "an Administrative Council of fourteen members";

b. By replacing the word: "board", in the first line of the second paragraph thereof, by the word: "Council".

6. Section 8 of the said act is amended:

a. By replacing the word: "board", in the first line of the first paragraph thereof, by the word: "Council";

b. By replacing the word: "association", in the first line of the said first paragraph thereof, by the word: "corporation";

c. By replacing the word: "association", in the third line of the first paragraph thereof, by the word: "corporation".

7. Section 10 of the said act is amended:

a. By replacing the word: "association", in the first line of the first paragraph thereof, by the word: "corporation";

b. By replacing the words: "board of directors", in the second and third lines of the second paragraph thereof, by the words: "Administrative Council".

8. Section 14 of the said act is amended:

a. By replacing the word: "association", in the first and second lines thereof, by the word: "corporation";

b. By replacing the words: "Licentiate in Accountancy", in the second and third lines thereof, by the words: "Certified Public Accountant";

c. By replacing the words: "*Licencié en comptabilité*", in the third line thereof, by the words: "*Comptable public licencié*";

d. By replacing the letters: "L.A.", in the fourth line thereof, by the letters: "C.P.A.".

9. Section 15 of the said act is amended by replacing the word: "association", in the fourth line thereof, by the word: "corporation".

Coming into
force.

10. This act shall come into force on the day of its sanction.
