



CHAPTER 76

An Act to amend article 704 of the Municipal Code

[Assented to, the 1st of April, 1927]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. Article 704 of the Municipal Code is amended by Mun. Code, adding thereto, after the second paragraph thereof, the ^{art. 704, am.} following paragraph:

“The local corporation may, however, appropriate the Appropriation of proceeds of licenses or permits issued in favour of rate-payers residing in a specified section of the municipality, ^{ceeds of licenses, etc.} for the payment either of sidewalks or of a water-works or lighting system established for such section of the municipality.”

2. This act shall come into force on the day of its ^{Coming into} sanction. _{force.}
