



CHAPTER 80

An Act respecting the cost of the paving of a certain part of Sherbrooke Street East in the city of Montreal

[Assented to, the 1st of April, 1927]

WHEREAS Emile Bernier, agent; James Cuddy, gentleman; Emmanuel Doucet, architect; Raoul Gariépy, architect; John Patrick Kelly, commercial traveller; Henri Pepin, gentleman; all six of the city and district of Montreal; the Canadian National Realities, Limited, and the Lachine Jacques-Cartier & Maisonneuve Railway Co., two bodies corporate, duly incorporated, having their head office in the city and district of Montreal; Albert J. Brown, K.C., advocate, E. Pancrasse Lespérance, manager, both of the city and district of Montreal, and Lawrence H. Hogan, gentleman, of Vancouver, B.C., all three acting in their quality of executors to the estate of the late Henri Hogan, in his lifetime hotelkeeper of the city and district of Montreal, the aforesaid petitioners, acting for themselves as well as for the other proprietors concerned, have, by their petition, represented that they are the owners of certain immoveable properties situate in the city of Montreal and fronting on Sherbrooke Street, between DeLorimier street and the C. P. R. tracks; Preamble.

Whereas the city of Montreal has undertaken certain works of paving on the aforesaid street and has given it the character and the width of a boulevard thus involving additional and considerable expenses and whereas the cost of those extraordinary works is charged to the proprietors of the lots fronting on the aforesaid part of Sherbrooke Street East;

Whereas the aforesaid extraordinary works being for the general interest of the city of Montreal, it is not just and reasonable that they should be paid by the owners of the said lots and it is in the interest of justice that the charter

of the city of Montreal be amended as hereinafter mentioned;

Whereas the city of Montreal by a resolution adopted on the 14th day of February, 1927, decided that the collection of assessments for the cost of the aforesaid paving be suspended until the Municipal Council have decided the question of the payment of the cost of the paving; and

Whereas it is expedient to grant the prayer contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The resolution adopted by the Municipal Council of the city of Montreal on the 14th of February, 1927, is hereby ratified, and, notwithstanding any provisions to the contrary, the collection of assessments for the cost of the paving of that part of Sherbrooke Street East, situated between DeLorimier Street and the C. P. R. tracks, is suspended until the Municipal Council of the city of Montreal shall have decided the question of the payment of the cost of paving and until a new assessment roll shall have been legally put into force for the payment of the cost of the paving of the said part of Sherbrooke Street East.
