



CHAPTER 13

An Act to amend the Revised Statutes, 1925, respecting
the exercise of certain public functions

[Assented to, the 11th of March, 1926]

HIS MAJESTY, with the advice and consent of the
Legislative Council and of the Legislative Assembly
of Quebec, enacts as follows:

1. Section 2 of the Public Officers Act (Revised Sta- R. S., c. 9,

“**19.** Such security shall be a guarantee also of the Security of

that the deputy, replacing the officer of justice who appointed him, furnish new security."

R. S., c. 155, s. 22, am. **3.** Section 22 of the Officers of Justice Salary Act (Revised Statutes, 1925, chapter 155) is amended by adding thereto the following paragraph:

Duties of deputy. "He shall also continue to perform his duties as deputy under the direction of the joint-officer in the cases provided for in the second paragraph of section 2 of the Public Officers Act (Chap. 9)."

R. S., c. 155, s. 23, am. **4.** Section 23 of the said Officers of Justice Salary Act is amended by adding thereto, after the word: "him", in the fourth line of the first paragraph thereof, the words: "or, in the cases provided for in the second paragraph of section 2 of the Public Officers Act (Chap. 9), under the direction of the joint-officers continued in office".

R. S., c. 262, s. 26, am. **5.** Section 26 of the Registry Office Act (Revised Statutes, 1925, chapter 262) is amended by adding thereto the following paragraph:

Powers of deputy-registrar. "In the cases provided for in the second paragraph of section 2 of the Public Officers Act (Chap. 9), the deputy-registrar shall continue to act as such under the direction of the joint-registrar."

Coming into force. **6.** This act shall come into force on the day of its sanction.
