



CHAPTER 70

An Act to authorize municipalities to contribute towards the construction of certain roads beyond their limits

[Assented to, the 24th of March, 1926]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. This act may be cited as *Municipal Road Construction Contribution Act*. Short title.

2. The council of any local or county municipality, no matter how constituted and by what law governed, may pass a by-law for the purpose of contributing, out of its general funds or by means of a loan, towards the construction of roads or bridges beyond the limits of the municipality.

Such by-law shall, in all cases, be submitted for the approval of the Lieutenant-Governor in Council, upon the recommendation of the Minister of Municipal Affairs, and, if it enacts a loan, it shall further be subject to all the other formalities of the laws governing the municipality with respect to municipal loans.

3. This act shall not apply to the roads mentioned in section 98 of the Roads' Act (Revised Statutes, 1925, chapter 91).

4. This act shall come into force on the day of its sanction.
