



CHAPTER 114

An Act to ratify certain resolutions of the municipal council and of the school commissioners of the parish of St. Joachim, county of Montmorency, and agreements between them and the St. Anne Power & Paper Company, Limited

[Assented to, the 24th of March, 1926]

WHEREAS the corporation of the parish of St. Joachim, Preamble.
county of Montmorency, on the 22nd of January, 1926, adopted a resolution to fix the total amount of the municipal assessments and other municipal taxes, for all taxable properties of the St. Anne Power & Paper Company, Limited, necessary for the exploitation of its industry, exclusive of all residential properties whatsoever, at not over two hundred and fifty dollars for the year in which the erection of said mill is begun, and at not over one thousand dollars for a period of ten years from the first of May of the year following that in which the said mill is built;

Whereas in accordance with such resolution and to give effect thereto, a contract or memorandum of agreement was entered into, in authentic form, between the corporation of the parish of St. Joachim and the St. Anne Power & Paper Company, Limited, before Claude Taschereau, notary, on the 23rd of January, 1926, setting forth and confirming in their tenor all and every the clauses and conditions mentioned in the above resolution;

Whereas at a meeting of the board of school commissioners of the municipality of St. Joachim, held on the 22nd of January, 1926, a resolution was adopted to fix the total amount of the school assessments and other school taxes for all the taxable properties of the St. Anne Power & Paper Company, Limited, necessary for the exploitation of its industry, exclusive of all residential properties whatsoever, at not over two hundred and fifty dollars for the

year in which the erection of said mill is begun, and at not over one thousand dollars for a period of ten years from the first of May of the year following that in which the said mill is built;

Whereas, in accordance with the tenor of such resolution of the board of school commissioners and to give effect thereto, a contract or memorandum of agreement, in authentic form, was entered into between the school commissioners of the municipality of St. Joachim and the St. Anne Power & Paper Company, Limited, before Claude Taschereau, notary, on the 22nd of January, 1926, setting forth and confirming in their tenor all and every the clauses and conditions mentioned in the said resolution;

Whereas the said resolutions and agreements state that they shall be valid only after confirmation and ratification by the Legislature;

Whereas the St. Anne Power & Paper Company, Limited, wishing to enjoy the benefits to be derived from the above-mentioned resolutions and agreements is now desirous of obtaining the ratification of the said resolutions and agreements by an act of the Legislature of Quebec;

Whereas the company-petitioner accordingly prays for the confirmation and ratification of the said resolutions and deeds of agreement; and

Whereas it is expedient to grant such prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Certain resolutions and deeds of agreement confirmed and ratified. **1.** The resolutions and deeds of agreement described as follows:

a. A resolution adopted by the municipal council of the corporation of the parish of St. Joachim, county of Montmorency, at its meeting of the 22nd of January, 1926, by which the corporation fixes the total amount of the municipal assessments and other municipal taxes, upon all the taxable properties of the St. Anne Power & Paper Company, Limited, necessary for the exploiting of its industry, exclusive of any residential properties whatsoever, at not more than two hundred and fifty dollars for the year in which the erection of the said mill is begun, and at not more than one thousand dollars for a period of ten years, to start from the first of May of the year following that in which the said mill is built;

b. A contract or memorandum of agreement, entered into between the corporation of the parish of St. Joachim, county of Montmorency, and the St. Anne Power & Paper Company, Limited, before Claude Taschereau, notary, on

the 22nd of January, 1926, to give effect to the above-mentioned resolution;

c. A resolution adopted by the school commissioners of the municipality of St. Joachim, at their meeting of the 22nd of January, 1926, fixing the total amount of school assessments or other school taxes, upon all the taxable properties of the St. Anne Power & Paper Company, Limited, necessary for the exploiting of its industry, exclusive of any residential properties whatsoever, at not more than two hundred and fifty dollars for the year in which the erection of the said mill is begun, and at not more than one thousand dollars for a period of ten years, to start from the first of May of the year following that in which the said mill is built;

d. A deed or memorandum of agreement entered into between the school commissioners of the municipality of St. Joachim, county of Montmorency, and the St. Anne Power & Paper Company, Limited, passed before Claude Taschereau, notary, on the 22nd of January, 1926, to give effect to the above resolution,—

Are hereby confirmed and ratified for all legal purposes.

2. This act shall apply only if the said mill is completed before the 1st of May, 1928. Application of act.

3. This act shall come into force on the day of its sanction. Coming into force.
