



CHAPTER 118

An Act to ratify certain resolutions of the corporation and of the school commissioners of the town of Drummondville and agreements between them and Canadian Celanese, Limited

[Assented to, the 24th of March, 1926]

WHEREAS the corporation of the town of Drummondville, on the 18th day of February, 1926, adopted a resolution to fix and commute the municipal taxes on all taxable properties of Canadian Celanese, Limited, on an increasing graded scale over a period of twenty (20) years, commencing from the 1st day of July, 1926;

Whereas in accordance with such resolution and to give effect thereto a contract or memorandum of agreement was entered into between the corporation of the town of Drummondville and Canadian Celanese, Limited, containing certain understandings between the parties and setting forth and confirming the fixing of municipal taxes hereinbefore mentioned;

Whereas, at a meeting of the board of school commissioners of the town of Drummondville held on the 16th day of February, 1926, a resolution was adopted to fix and commute the total amount of all school taxes on all the taxable properties of Canadian Celanese, Limited, upon a graded scale over a period of twenty (20) years from the 1st day of July, 1926;

Whereas in accordance with such resolution and to give effect thereto a contract or memorandum of agreement was entered into between the school commissioners of the town of Drummondville containing the understanding of the parties and setting forth and confirming the clauses and conditions mentioned in the said resolution, and to the said agreement there intervened the school trustees of the said town of Drummondville who did confirm, for all intents and purposes, the resolution of the board of school commissioners touching the said fixing of taxes;

Whereas said resolutions and agreements state that they shall, in order to be valid, require to be ratified by the Legislature;

Whereas Canadian Celanese, Limited, is now desirous of obtaining the ratification of the said resolutions and agreements by an act of the Legislature of Quebec;

Whereas the company-petitioner accordingly prays for the confirmation and ratification of the said resolutions and deeds of agreement; and

Whereas it is expedient to grant such prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

- 1.** The following resolutions and deeds of agreement are hereby confirmed, ratified and made obligatory for all legal purposes:
- Resolutions and contracts ratified. *a.* A resolution, adopted by the corporation of the town of Drummondville at its meeting of the 18th day of February, 1926; referring to Canadian Celanese, Limited;
- Resolution of 18th of Feb., 1926;
- Contract of 18th of Feb., 1926; *b.* A contract or memorandum of agreement, entered into between the corporation of the town of Drummondville and Canadian Celanese, Limited, on the 18th day of February, 1926, to give effect to the above-mentioned resolution;
- Resolution of 16th of Feb., 1926; *c.* A resolution, adopted by the board of school commissioners of the town of Drummondville at their meeting of the 16th day of February, 1926, referring to Canadian Celanese, Limited;
- Contract of 16th of Feb., 1926. *d.* A deed or memorandum of agreement, entered into between the board of school commissioners of the town of Drummondville and Canadian Celanese, Limited, on the 16th day of February, 1926, in which agreement intervened the school trustees of the said town, and which agreement was for the purpose of giving effect to the above resolution.
- Submission of water and sewerage plans, etc. **2.** The company shall submit to the Director of the Provincial Bureau of Health, for his approval, its water and sewerage plans as well as all its general plans for parks and amusement grounds in relation to its industry.
- Coming into force. **3.** This act shall come into force on the day of its sanction.
