



CHAPTER 120

An Act to ratify certain resolutions of the school commissioners of the school municipality of St. Edouard de Fraserville and of the trustees of the dissentient school municipality of Fraserville and agreements between the same and The Warren Company, Limited

[Assented to, the 24th of March, 1926]

WHEREAS at a meeting of the school commissioners Preamble.
of the school municipality of St. Edouard de Fraserville, held on the 18th of June, 1925, a resolution was adopted granting to Mr. K. L. Warren, of the city of Rivière du Loup, civil engineer, his successors and assigns, a commutation of school taxes, for a period of ten years, at an annual rate of seven hundred and fifty dollars (\$750.00), starting from the 1st of July, 1925, upon his moveable and immoveable property;

Whereas such commutation of taxes was so granted to the said K. L. Warren upon the following conditions, namely:

a. That the said K. L. Warren do sign in favour of the school board an undertaking for himself, his successors and assigns, to spend a sum of at least thirty thousand dollars in the reorganization of the pulp factory existing in the city of Rivière du Loup within two years, otherwise the said resolution of the 18th of June, 1925, would be null and void, and to pay to the said school board the arrears due amounting to a sum of six thousand seven hundred and forty-five dollars and fifty-eight cents (\$6,745.58);

b. That the said K. L. Warren undertakes to have the present arrangement ratified by the Legislature of the Province of Quebec with the support, however, of the said school board in obtaining such ratification;

c. That the said resolution shall come into force only when the said K. L. Warren shall have paid to the said school board one of the years of arrears of taxes, to wit, the

sum of nineteen hundred and seventy-five dollars (\$1,975.-00) for one year of arrears and the interest on said sum;

Whereas, on the 7th of July, 1925, the trustees of the dissentient school corporation of Fraserville duly approved the aforesaid resolution of the school commissioners of the school municipality of St. Edouard de Fraserville;

Whereas the said K. L. Warren, on the 26th of September, 1925, duly paid to the said school commissioners of the said school municipality of St. Edouard de Fraserville the said sum of nineteen hundred and seventy-five dollars (\$1,975.00), with the interest on same, as required by the said resolutions;

Whereas the work of reorganizing the pulp factory required by said resolutions is in course of execution;

Whereas by deed, dated the 21st of January, 1926, at Rivière du Loup, passed before J. Oscar Lévesque, notary, the said K. L. Warren transferred to The Warren Company, Limited, a legal corporation, having its chief place of business in the city of Rivière du Loup, Province of Quebec, all the rights conferred upon him by the said resolutions;

Whereas in order to carry out and give effect to the aforesaid resolutions and deed of transfer, the school commissioners of the school municipality of St. Edouard de Fraserville and the trustees of the dissentient school corporation of Fraserville have respectively authorized their chairmen to accept and sign a deed of agreement with The Warren Company, Limited, for the aforesaid purposes;

Whereas in accordance with the tenor of such resolutions and to give effect thereto, a contract or memorandum of agreement was passed in authentic form between the school commissioners of the school municipality of St. Edouard de Fraserville, the trustees of the dissentient school corporation of Fraserville and The Warren Company, Limited, before J. Oscar Lévesque, notary, at Rivière du Loup, on the 21st of January, 1926, setting forth and confirming in their tenor all and every the clauses and conditions mentioned in the said resolutions;

Whereas the said resolutions stipulated that the privileges, benefits and obligations, therein mentioned, may be transferred to the successors and representatives of The Warren Company, Limited;

Whereas the said resolutions and agreement stipulate that they shall be valid only after confirmation and ratification by the Legislature;

Whereas The Warren Company, Limited, in order to enjoy the advantages to be derived from the above-mentioned resolutions and agreement, now desire to obtain ratification of the said resolutions and agreement by an act of the Legislature;

Whereas the company-petitioner has accordingly prayed for the confirmation and ratification of said resolutions and deed of agreement; and

Whereas it is expedient to grant such prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The resolutions and deed of agreement, described as follows: Certain resolutions and deed, confirmed and ratified.

a. A resolution adopted by the school commissioners of the school municipality of St. Edouard de Fraserville, at their meeting of the 18th of June, 1925, fixing, for a period of ten years, starting from the 1st of July, 1925, at the sum of seven hundred and fifty dollars (\$750.00), the annual school taxes on the moveable and immoveable property of Mr. K. L. Warren, his successors and assigns, used for industrial purposes in the city of Rivière du Loup;

b. A resolution adopted by the trustees of the dissentient school corporation of Fraserville, at their meeting of the 7th of July, 1925, confirming and ratifying the resolution adopted by the school commissioners of the school municipality of St. Edouard de Fraserville;

c. A deed or memorandum of agreement between the school commissioners of the school municipality of St. Edouard de Fraserville, the trustees of the dissentient school corporation of Fraserville and The Warren Company, Limited, passed before J. Oscar Lévesque, notary, to give effect to the resolutions of the said school boards,—

Are ratified and confirmed for all legal purposes.

2. This act shall come into force on the day of its sanction. Coming into force.
