



## CHAPTER 132

An Act to change the family name of John Alexander Middleton and Douglas Orrin Middleton to Bremner

[Assented to, the 11th of March, 1926]

**W**HEREAS John Alexander Middleton, merchant, of Preamble. the city of Westmount, district of Montreal, and Douglas Orrin Middleton, known under the name of Douglas Orrin Bremner, student, of the same place, have, by their petition, represented that they are and have always been known under the family name of Bremner, although their real name was Middleton, and are desirous of having their family name of Middleton changed to Bremner, and have prayed for an act for that purpose, and it is expedient to grant their prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** The family name of the said petitioners is hereby Name changed from Middleton to Bremner, and they shall here- after be called and known by the latter name; under such name they shall hereafter enjoy, exercise and claim all advantages, benefits, rights and titles, which, without such change of name, they would have been entitled to; all contracts, covenants, agreements and wills made and entered into by them under the one or the other name shall avail to and be deemed to be entered into by them, by and under the name Bremner; all legacies, bequests or gifts contained in any will, deed of donation, policy of insurance, or otherwise, made in their favour under the former name, shall avail to them under the latter; by the latter name they shall recover, have, hold, possess, and be capable of inheriting all real and personal property and rights of any kind or nature whatsoever, which they may at present have, hold or possess, or which hereafter they may be ca-

pable of inheriting, recovering, holding or possessing, as fully and to the same extent as if such change of name had not been made.

**2.** All obligations entered into by the said petitioners shall be exigible against them under such new name, and all suits or actions at law, to which they may be parties, pending in any court of this Province, shall not be affected by this act, but shall be continued to judgment and execution as if this act had not been passed.

**3.** All rights and privileges generally of whatever nature and kind whatsoever that may be hereby acquired by the said petitioners, and which may hereafter be acquired under this act, shall apply to their children and descendants.

**4.** This act shall come into force on the day of its sanction.
