

C H A P. 2

An Act respecting certain debentures or inscribed stock of
the Government of this Province

[Assented to, the 3rd of April, 1925]

HIS MAJESTY, with the advice and consent of the
Legislative Council and of the Legislative Assembly
of Quebec, enacts as follows:

1. Section 10 of the act 3 George V, chapter 6, as amend-3 Geo. V, c. ed by the acts 8 George V, chapter 12, section 2, and 14⁶, s. 10, am. George V, chapter 2, section 1, is again amended by inserting therein, after the word: "place", in the twelfth line thereof, the following words: "or places".

2. Section 1 of the act 5 George V, chapter 2, is amend-5 Geo. V, c. ed by inserting therein after the word: "place", in the², s. 1, am. eleventh line thereof, the following words: "or places".

3. Section 5 of the act 5 George V, chapter 4, as amend-5 Geo. V, c. ed by the acts 8 George V, chapter 14, section 1, and 14⁴, s. 5, am. George V, chapter 2, section 2, is again amended by inserting therein, after the word: "place", in the thirteenth line thereof, the following words: "or places".

4. Section 5 of the act 8 George V, chapter 13, as amend-8 Geo. V, c. ed by the acts 14 George V, chapter 2, section 3, and 14¹³, s. 5, am. George V, chapter 9, section 1, is again amended by inserting therein, after the word: "place", in the fifth line of the third paragraph thereof, the following words: "or places".

5. Section 2 of the act 10 George V, chapter 6, as amend-10 Geo. V, c. ed by the act 14 George V, chapter 2, section 4, is again⁶, s. 2, am. amended by inserting therein, after the word: "place", in the eighth line thereof, the following words: "or places".

6. Section 74 of the act 13 George V, chapter 34, as 13 Geo. V, c. amended by the act 14 George V, chapter 2, section 7, is³⁴, s. 74, am. again amended by inserting therein, after the word: "place", in the eighth line thereof, the following words: "or places".

7. This act shall also apply to all debentures or inscribed Application. stock issued before the third day of April, 1925, in connection with the loans authorized by the above-mentioned acts.

Coming into force. **8.** This act shall come into force on the day of its sanction.

C H A P. 3

An Act respecting certain payments made to the Crown

[Assented to, the 3rd of April, 1925]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Payment of duties or taxes to Government. Prescription. **1.** Every right of action for the recovery of sums of money heretofore or hereafter paid through error in law to the Government of the Province as duties or taxes, imposed by any act of the Legislature, is absolutely extinguished if the action has not been instituted within six months from the date of the payment.

Coming into force. **2.** This act shall come into force on the day of its sanction.

C H A P. 4

An Act to amend the act to provide for the construction and maintenance of bridges at Ile Perrot

[Assented to, the 4th of March, 1925]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

11 Geo. V, c. 9, s. 1, am. **1.** Section 1 of the act 11 George V, chapter 9, is amended by replacing the words: "six hundred thousand dollars", in the fifth and sixth lines thereof, by the words: "eight hundred and fifty thousand dollars".

Id., s. 3, am. **2.** Section 3 of the said act is amended by replacing the words: "six hundred thousand dollars", in the twelfth line of the first paragraph thereof, by the words: "eight hundred and fifty thousand dollars".

Coming into force. **3.** This act shall come into force on the day of its sanction.
