An Act to amend The Alcoholic Liquor Possession and Transportation Act

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

CHAP. 25

An Act to amend the Quebec License Act

[Assented to, the 3rd of April, 1925]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

replaced. **1.** Article 963 of the Revised Statutes, 1909, as enacted by the act 11 George V, chapter 26, section 1, is replaced by the following article:

"963. The Lieutenant-Governor in Council may:

1. Determine the conditions upon which bets, wagers or pools may be received, recorded, or sold under the system known as the *pari mutuel* system, whenever, at a horse-race meeting, such races consist of trotting or pacing races;

2. Require and regulate the use of apparatus to automatically determine the total amount of the bets under the *pari mutuel* system and the number of persons attending a race-meeting."

2. Article 968 of the Revised Statutes, 1909, as enacted R. S., 968, by the act 11 George V, chapter 26, section 1, is amended ^{am.} by adding thereto, after the word: "stock", in the second line thereof, the words: "and raw furs".

b. By adding thereto, after the word: "things", in the eighth line thereof, the words: "but such word shall not mean cartridges".
