As to the rest, the provisions of paragraphs 2, 3, 4, 6, 7, 8 and 9 of article 3090 of the Revised Statutes, 1909, as amended by the acts 5 George V, chapter 13, section 7, paragraph E; 12 George V, chapter 21, section 9, paragraph B, and 13 George V, chapter 49, section 2, shall apply, *mutatis mutandis*, to this article as if they formed part thereof."

CHAP. 49

An Act to amend the Revised Statutes, 1909, respecting the Magistrate's Court

[Assented to, the 4th of March, 1925]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

R. S., 3187. **1.** Article 3187 of the Revised Statutes, 1909, is amended by adding thereto, after the word: "court", in the third line of the third paragraph thereof, the words: "They may likewise act in matters relating to the seizure of moveables with the same powers as a bailiff of the Superior Court, for matters and things within the jurisdiction of the Magistrate's Court."

R. S., 3310. **2.** Article 3310 of the said Statutes, as replaced by the act 12 George V, chapter 64, section 1, is amended by adding thereto, after the word: "determine", in the third line thereof, the words: "and the latter is authorized to defray the cost of the premises required for holding such courts. These costs shall be paid out of the consolidated revenue fund."

R. S., 3313. **3.** Article 3313 of the said Statutes, as replaced by the act 12 George V, chapter 64, section 1, is amended by adding thereto the following paragraph:

"The Lieutenant-Governor in Council may grant to each of the clerks of the Magistrates' Courts established in and for the county of Saguenay, over and above the fees they are authorized to receive under the tariffs, such addi-

tional remuneration, not to exceed two hundred dollars per county of annum, as he may be pleased to fix.” ^{Saguenay.}

C H A P. 50

An Act to amend the Revised Statutes, 1909, respecting
the Clerk of the Peace in the district of Pontiac

[Assented to, the 4th of March, 1925]

HIS MAJESTY, with the advice and consent of the
Legislative Council and of the Legislative Assembly
of Quebec, enacts as follows:

1. The Revised Statutes, 1909, are amended by inserting ^{R. S., 3187a} therein, after section fifth of chapter second of title sixth ^{to 3187e,} thereof, the following section and articles: ^{added.}

“SECTION Va

“PEACE OFFICE IN THE DISTRICT OF PONTIAC, AT TEMISCAMINGUE

“3187a. The Lieutenant-Governor in Council may by ^{Peace Office} proclamation order the establishment of a Peace Office, ^{for the dis-} and for the district of Pontiac, at Temiscamingue, in pre- ^{trict of Pon-} mises chosen and designated by him in the said procla- ^{tiae at Te-} mation. ^{miscamin-} ^{gue.}

“3187b. The Lieutenant-Governor in Council shall ^{Deputy-} appoint, during pleasure, a person with sufficient capacity ^{Clerk of the} and experience in the practice before the courts of the Prov- ^{Peace.} ince in criminal matters to keep such Peace Office as Deputy- ^{Salary and} Clerk of the Peace, and shall fix his salary; and such Deputy- ^{accounting.} Clerk of the Peace shall render account to the Provincial Treasurer of the fees and emoluments collected by him in the exercise of his functions, under whatsoever title.

He may likewise appoint the additional employees that ^{Additional} he may deem expedient to assist such Deputy in the carry- ^{employees.} ing out of his duties, and may fix the salary of such employees.
