C H A P. 68

An Act to amend the Revised Statutes, 1909, respecting
the winding up of joint stock companies

[Assented to, the 3rd of April, 1925]

HIS MAJESTY, with the advise and consent of the
Legislative Council and of the Legislative Assembly
of Quebec, enacts as follows:

1. Article 6122 of the Revised Statutes, 1909, is amended R. S., 6122,
by replacing the words: "by a majority representing not ^{am.}
less than two-thirds of the stock", in the fourth and fifth
lines thereof, by the words: "by the vote of at least two-
thirds in value of the shares represented by the shareholders
present".

C H A P. 69

An Act to amend the Revised Statutes, 1909, respecting
co-operative syndicates

[Assented to, the 3rd of April, 1925]

HIS MAJESTY, with the advice and consent of the
Legislative Council and of the Legislative Assembly
of Quebec, enacts as follows:

1. Article 6763 of the Revised Statutes, 1909, as amend- R. S., 6763,
ed by the acts 2 George V, chapter 43, section 1; 5 George ^{am.}
V, chapter 68, section 1, and 8 George V, chapter 65, section
1, is again amended by replacing the first paragraph thereof
by the following:

"6763. Co-operative syndicates for consumption, pro- Co-opera-

this section." _{formed.}

R. S., 6782, **2.** Article 6782 of the Revised Statutes, 1909, is amended by adding thereto, after the fourth paragraph thereof, the following paragraph:

Verification. "The board of supervision of co-operative syndicates for credit, provident and other economical purposes shall, at least once a year, cause all the operations of the association to be verified by an inspector of a federation organized under article 6809. Such verification shall be made at the cost of the syndicate unless it has already been affiliated with a federation."

R. S., 6796, **3.** Article 6796 of the Revised Statutes, 1909, as amended by the act 1 George V (1911), chapter 43, section 11, and replaced by the act 5 George V, chapter 68, section 2, is amended by adding thereto the following paragraph:

Report verified. "Co-operative syndicates for credit, provident and other economical purposes shall have such report verified by the inspector of a federation organized under article 6809, which inspector shall approve the same if there be occasion therefor."

Coming into force. **4.** This act shall come into force on the day of its sanction.

CHAP. 70

An Act respecting the keeping of registers of civil status by certain Protestant churches and congregations

[Assented to, the 3rd of April, 1925]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

R. S., 7251, **1.** Article 7251 of the Revised Statutes, 1909, as amended by the act 14 George V, chapter 68, section 1, is again amended by inserting therein, after the word: "Scotland", in the fourth line of the first paragraph thereof, the words: "or The United Church of Canada and that church itself or the non-concurring congregations mentioned in the Act of the Parliament of Canada, 14-15 George V, chapter 100, or the church or churches formed by the union of any of said non-concurring congregations".

Coming into force. **2.** This act shall come into force on the day of its sanction.
