Whereas these facts have been brought to the knowledge of the General Council of the Bar of the Province and the said Council has granted his request asking for permission to present a bill at the present session of the Legislature, which would authorize him to exercise his profession as soon as such bill was passed;

Whereas the petitioner has prayed for the passing of an act for the purposes aforesaid, and it is expedient to grant his prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly, of Quebec, enacts as follows:

CHAP. 166

An Act to authorize the Bar of the Province of Quebec to admit Frank Devlin Genest to the practice of law, after examination

[Assented to, the 4th of March, 1925]

Preamble. **W**HEREAS Frank Devlin Genest, law student of the city of Westmount, has, by his petition, represented:

That in May, 1921, he matriculated at McGill University, Montreal, having regularly followed the course of the Law Faculty during three years and obtained the diploma of Bachelor of Civil Law;

That he was duly admitted to the study of law;

That following graduation from McGill University he sat for the admission to practice examinations, on three distinct occasions, but that owing to a weakened constitution caused by his physical disability he was unequal to the long strain of the written examinations and could not complete his papers, notwithstanding the fact that he was well prepared in the legal studies;

That he is suffering from a permanent physical disability the result of which is that he is not able to endure physical strain over a prolonged period;

That through no fault of his he is thus prevented from successfully passing the written bar examinations and is thus unable to practise his profession;

That the strain of passing an oral examination is not so considerable and that he would have enough strength to undergo such examination;

That, at a meeting of the General Council of the Bar of the Province of Quebec, held at Montreal, on the 8th of January, 1925, he was given permission to apply to the Legislature for an act authorizing the Bar of the Province of Quebec to admit him to the practice of law, after passing an oral examination only;

Whereas the said Frank Devlin Genest has prayed that an act be passed for the purposes above mentioned and it is expedient to grant his prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The Bar of the Province of Quebec is hereby authorized to admit Frank Devlin Genest to the practice of law, after passing an oral examination only, and after having accomplished all the formalities required in such cases. Bar authorized to admit F. D. Genest.

2. This act shall come into force on the day of its sanction. Coming into force.

C H A P. 167

An Act to authorize the Bar of the Province of Quebec to admit Frederick L. Martyn amongst its members, after examination

[Assented to, the 4th of March, 1925]

WHEREAS Frederick L. Martyn, law student, of the city of Montreal, has, by his petition, represented:

That he is a British subject of the age of forty-one years and a Bachelor of Arts;

That he was duly admitted to the study of law on the 10th of January, 1924, as a Bachelor of Arts of the University of Montreal;

That he was indentured as clerk to Mtre. J. L. Perron, K.C., advocate of Montreal, on the 8th of April, 1924, before Mtre. Henri Baby, notary public;
