

That he is suffering from a permanent physical disability the result of which is that he is not able to endure physical strain over a prolonged period;

That through no fault of his he is thus prevented from successfully passing the written bar examinations and is thus unable to practise his profession;

That the strain of passing an oral examination is not so considerable and that he would have enough strength to undergo such examination;

That, at a meeting of the General Council of the Bar of the Province of Quebec, held at Montreal, on the 8th of January, 1925, he was given permission to apply to the Legislature for an act authorizing the Bar of the Province of Quebec to admit him to the practice of law, after passing an oral examination only;

Whereas the said Frank Devlin Genest has prayed that an act be passed for the purposes above mentioned and it is expedient to grant his prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** The Bar of the Province of Quebec is hereby authorized to admit Frank Devlin Genest to the practice of law, after passing an oral examination only, and after having accomplished all the formalities required in such cases. Bar authorized to admit F. D. Genest.

**2.** This act shall come into force on the day of its sanction. Coming into force.

#### C H A P. 167

An Act to authorize the Bar of the Province of Quebec to admit Frederick L. Martyn amongst its members, after examination

[Assented to, the 4th of March, 1925]

**W**HEREAS Frederick L. Martyn, law student, of the city of Montreal, has, by his petition, represented:

That he is a British subject of the age of forty-one years and a Bachelor of Arts;

That he was duly admitted to the study of law on the 10th of January, 1924, as a Bachelor of Arts of the University of Montreal;

That he was indentured as clerk to Mtre. J. L. Perron, K.C., advocate of Montreal, on the 8th of April, 1924, before Mtre. Henri Baby, notary public;

That he had previously studied in the office of Mtre. T. Brosseau, K.C., advocate of Montreal, for nearly eight years;

That now he wishes to be admitted as a member of the Bar of the Province of Quebec, after undergoing the usual examinations for admission to practise law, and to be allowed to begin the exercise of his profession immediately thereafter;

That, at its meeting of the 26th of September, 1924, the General Council of the Bar of the Province of Quebec passed a resolution approving of the passing of an act to relieve him from the above mentioned irregularities, for the purposes aforesaid;

Whereas he has prayed for an act for the purposes above mentioned and it is expedient to grant his prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Bar authorized to admit F. L. Martyn.

**1.** The Bar of the Province of Quebec is authorized to admit the said Frederick L. Martyn amongst its members after he has undergone the usual examinations for admission to the practice of law, and to allow him to exercise the profession of advocate immediately after he has successfully undergone the said examinations.

Coming into force.

**2.** This act shall come into force on the day of its sanction.

## CHAP. 168

An Act to authorize the Bar of the Province of Quebec to admit James Kenneth Mathews Ross among its members

[Assented to, the 4th of March, 1925]

Preamble.

**WHEREAS** James Kenneth Mathews Ross, law student, of the city of Montreal, has, by his petition, represented:

That he is a British subject of the full age of majority;

That he is a graduate of Cambridge University, England, from which institution he received the degrees of Bachelor of Arts and Bachelor of Law, with honours in law;

That the course in law at the University of Cambridge is founded upon the civil law;

That he now wishes to be admitted as a member of the Bar of the Province of Quebec after undergoing the usual
