

That he had previously studied in the office of Mtre. T. Brosseau, K.C., advocate of Montreal, for nearly eight years;

That now he wishes to be admitted as a member of the Bar of the Province of Quebec, after undergoing the usual examinations for admission to practise law, and to be allowed to begin the exercise of his profession immediately thereafter;

That, at its meeting of the 26th of September, 1924, the General Council of the Bar of the Province of Quebec passed a resolution approving of the passing of an act to relieve him from the above mentioned irregularities, for the purposes aforesaid;

Whereas he has prayed for an act for the purposes above mentioned and it is expedient to grant his prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Bar authorized to admit F. L. Martyn.

**1.** The Bar of the Province of Quebec is authorized to admit the said Frederick L. Martyn amongst its members after he has undergone the usual examinations for admission to the practice of law, and to allow him to exercise the profession of advocate immediately after he has successfully undergone the said examinations.

Coming into force.

**2.** This act shall come into force on the day of its sanction.

## CHAP. 168

An Act to authorize the Bar of the Province of Quebec to admit James Kenneth Mathews Ross among its members

*[Assented to, the 4th of March, 1925]*

Preamble.

**WHEREAS** James Kenneth Mathews Ross, law student, of the city of Montreal, has, by his petition, represented:

That he is a British subject of the full age of majority;

That he is a graduate of Cambridge University, England, from which institution he received the degrees of Bachelor of Arts and Bachelor of Law, with honours in law;

That the course in law at the University of Cambridge is founded upon the civil law;

That he now wishes to be admitted as a member of the Bar of the Province of Quebec after undergoing the usual

examinations for admission to practise law and to be authorized to practise his profession immediately thereafter;

That at its meeting held on November 8th, 1924, the General Council of the Bar of the Province of Quebec passed a resolution approving the passing of this act provided he fyle with the secretary-general his diploma establishing that he is a Bachelor of Law of Cambridge University;

That the secretary-general has produced a certificate of the fying of such diploma;

And whereas the petitioner has prayed for the passing of an act for the aforesaid purposes, and it is expedient to grant his prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** The Bar of the Province of Quebec is authorized to Bar admit the said James Kenneth Mathews Ross among its authorized members after he has undergone the regular examinations to admit for admission to practise law, and the Bar of the Province James Ken- of Quebec is further authorized to allow him to practise law neth Ma- immediately after having successfully passed the said ex- thews Ross. aminations.

## CHAP. 169

An Act to authorize the College of Physicians and Surgeons of the Province of Quebec to admit Robert Fiset to the practice of medicine and surgery, after examination

[Assented to, the 4th of March, 1925]

**W**HEREAS Robert Fiset, of the city and district of Preamble. Quebec, has, by his petition, represented:

That, in September, 1920, he was admitted as a student of medicine and surgery of Laval University, Quebec, and has attended the medical course of said university during the regular university years;

That it was only in July, 1921, that he obtained from the College of Physicians and Surgeons of the Province of Quebec the permit allowing him to study medicine, which for serious reasons he could not obtain before his entry to said university;

That, in view of the foregoing, the College of Physicians and Surgeons of the Province of Quebec has consented to a
