

examinations for admission to practise law and to be authorized to practise his profession immediately thereafter;

That at its meeting held on November 8th, 1924, the General Council of the Bar of the Province of Quebec passed a resolution approving the passing of this act provided he file with the secretary-general his diploma establishing that he is a Bachelor of Law of Cambridge University;

That the secretary-general has produced a certificate of the filing of such diploma;

And whereas the petitioner has prayed for the passing of an act for the aforesaid purposes, and it is expedient to grant his prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The Bar of the Province of Quebec is authorized to Bar admit the said James Kenneth Mathews Ross among its authorized members after he has undergone the regular examinations to admit for admission to practise law, and the Bar of the Province James Kenneth Mathews Ross of Quebec is further authorized to allow him to practise law immediately after having successfully passed the said examinations.

2. This act shall come into force on the day of its Coming into sanction. force.

CHAP. 169

An Act to authorize the College of Physicians and Surgeons of the Province of Quebec to admit Robert Fiset to the practice of medicine and surgery, after examination

[Assented to, the 4th of March, 1925]

WHEREAS Robert Fiset, of the city and district of Preamble. Quebec, has, by his petition, represented:

That, in September, 1920, he was admitted as a student of medicine and surgery of Laval University, Quebec, and has attended the medical course of said university during the regular university years;

That it was only in July, 1921, that he obtained from the College of Physicians and Surgeons of the Province of Quebec the permit allowing him to study medicine, which for serious reasons he could not obtain before his entry to said university;

That, in view of the foregoing, the College of Physicians and Surgeons of the Province of Quebec has consented to a

bill being presented authorizing the petitioner to practise medicine, after successfully undergoing the 3rd, 4th and 5th year examinations before the Medical Board;

Whereas the petitioner has prayed that an act be passed to that effect, and it is expedient to grant such prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The College of Physicians and Surgeons of the Province of Quebec is authorized to admit the said Robert Fiset among its members, and to grant him the necessary license for the practice of medicine in the Province of Quebec, after he has successfully undergone the 3rd, 4th and 5th year examinations before the Medical Board.

C H A P. 170

An Act to authorize the College of Physicians and Surgeons of the Province of Quebec to admit Adrien Lebrun to the practice of medicine, surgery and obstetrics.

[Assented to, the 4th of March, 1925]

Preamble.

WHEREAS Adrien Lebrun, of the city and district of Montreal, has, by his petition represented:

That he was admitted as a medical student in September 1913 to Laval University of Montreal and attended the medical course of the said university for the regular five years;

That he suspended his studies for five years through ill health and to do military service;

That the University of Montreal granted him his degree of Doctor of Medicine in June 1923;

That he began his course at the said university without passing the examinations for admission to the study of medicine;

That he possesses the qualifications required to practise medicine but cannot receive a license to practise in the Province of Quebec without special authorization from the Legislature;

That he obtained the consent of the College of Physicians and Surgeons of the Province of Quebec on the 24th of September, 1924, to the passing of a bill to authorize such College to admit him amongst its members and to grant
