## C H A P . 13

An Act to ratify the contract respecting the Paper-Making  
School of Three Rivers

[Assented to, the 15th of March, 1924]

**HIS MAJESTY**, with the advice and consent of the  
Legislative Council and of the Legislative Assembly  
of Quebec, enacts as follows:

**1.** The contract entered into on the ninth day of Jan-  
uary, 1924, between the Minister of Lands and Forests and  
the president of the corporation of the Three Rivers Tech-  
nical School, reproduced in the schedule to this act, is  
hereby ratified. Contract between the

**2.** This act shall come into force on the day of its sanction. Coming into force.

## SCHEDULE

In the year one thousand nine hundred and twenty-four,  
on the ninth day of the month of January,

### APPEARED:

THE GOVERNMENT OF THE PROVINCE OF QUEBEC, herein  
represented by the Honourable Honoré Mercier, Min-  
ister of Lands and Forests, duly authorized for the pur-  
poses of these presents by an Order-in-Council, dated  
the twentieth of September, nineteen hundred and  
twenty-three, and approved on the same day by His  
Honour the Lieutenant-Governor of the Province of  
Quebec, whereof a certified copy has been annexed to  
the original hereof, after having been signed by the  
parties and the undersigned notary, for identification,  
party of the first part,

Hereinafter called the Government,

## AND

THE THREE RIVERS TECHNICAL SCHOOL, a corporation duly constituted by the statute of the Province of Quebec, 8 George V, chapter 42, and its amendments, hereto represented by Mr. Louis Philippe Mercier, in his capacity of President, duly authorized for these presents by resolution passed on the second day of the month of January, nineteen hundred and twenty-four, whereof a certified copy has been annexed to the original hereof, after having been signed by the parties and the undersigned notary, for identification, party of the second part,

Hereinafter called the Corporation.

Which said parties have declared and covenanted between themselves as follows, to wit:

Whereas under the Provincial Statute, 13 George V, chapter 31, the Government was authorized, amongst other things, to establish and organize a complete education in paper-making in the Province of Quebec with a view to training expert workmen as well as technicians for the making of woodpulp, paper and other similar products or by-products of the fibre.

Whereas the city of Three Rivers is one of the best places to establish such a school, as it now forms one of the most important centres of the pulp and paper industry, and whereas instruction in paper-making can be easily given in the building belonging to the Three Rivers Technical School without its being necessary to erect new buildings there at present.

Whereas the Corporation is prepared to make the necessary arrangements with the Government so that the latter may establish a paper-making school there.

Therefore the parties have covenanted as follows, to wit:

The Corporation agrees to the Government's organizing and maintaining in the building belonging to it at Three Rivers, above-mentioned, a paper-making school to be operated simultaneously with the Technical School under the direction of one and the same director of studies, for a period of twenty years from this date, but the Government may bring the present agreement to an end at any time by giving a written notice of six months to the Corporation of its intention to that effect.

Such paper-making school shall be placed under the sole control of the Minister of Lands and Forests who shall have all the rights and privileges conferred upon him by the Statute of Quebec, 13 George V, chapter 31, already cited.

The Minister shall appoint the director of the Paper-Making School who shall at the same time be the principal director of the Technical School.

All equipment, paid for by the Government, shall remain the property of the latter.

In consideration of the permission hereby granted to it by the Corporation to open said paper-making school in the latter's building, the Government undertakes to pay, in due time and as long as the present agreement remains in force and effect, a sum sufficient to meet the interest and sinking-fund of the bonds issued by the Corporation.

The Government shall pay the said interest and sinking-fund directly to those entitled thereto.

The Government shall maintain and keep in good order the building belonging to said Corporation as well as the machinery, tools, furniture and all instruction material; pay the salaries of the director and principal, of the professors, foremen and other employees, both for the technical instruction and for instruction in the manufacture of pulp and paper; pay for the heating and lighting of the building as well as for the premiums for fire insurance upon the building, machinery, tools and furniture; pay the municipal and school taxes and other real estate assessments affecting the Corporation's immoveable property; pay all other charges of whatsoever nature without distinction so that the said Corporation will have nothing whatever to pay.

The Government shall, in addition, assume the payment of the promissory notes which the Corporation has made in favour of the Bank of Montreal and the other accounts and debts of the Corporation contracted before this date, the whole according to the lists hereto annexed and signed by the parties and the said notary for identification.

By the payment of the aforesaid sums and in consideration of these presents, the Corporation transfers to the Government all the grants which it now receives or may hereafter receive from the Province of Quebec, the city of Three Rivers or any other source.

This agreement shall come into force and effect from and after the date of its ratification by the Legislature of the Province of Quebec.

DONE AND PASSED at Quebec, on the day and year above-mentioned, under the number ten thousand nine hundred and seventy-five of the records of the undersigned notary.

Respecting the Paper-Making School of Three Rivers.

---

The Honourable Minister of Lands and Forests in a memorandum dated 20th of September, (1923), sets forth: that under the act 13 George V, chapter 31, sections 1 and 3, the Government was authorized to establish and organize schools or chairs for the instruction of paper-making in this Province;

That the city of Three Rivers is one of the best places to establish one of such schools, as being one of the most important centres of the pulp and paper industry;

That instruction in paper-making can be easily given in the building belonging to the Three Rivers Technical School, without its being necessary to erect new buildings there at present;

That the corporation of the Three Rivers Technical School is prepared to make the necessary arrangements for the purpose of establishing said paper-making school;

Therefore, the Honourable Minister recommends:

1. That the Government of this Province, represented for the purpose by the Minister of Lands and Forests, be authorized:

(a) to establish and organize a school or chair of paper-making in the city of Three Rivers;

(b) to retain the services of directors, professors and employees required for the operation and maintenance of the school or chair;

(c) to make arrangements for the above purposes with the corporation of the Three Rivers Technical School and, if necessary, the city of Three Rivers.

2. That Order-in-Council No. 1024 of the 26th of June, 1923, be repealed.

Extract from the minutes of the 49th meeting of the Board of Directors of the Three Rivers Technical School.

A meeting of the Board of Directors of the Three Rivers Technical School was held in the Technical School on the 2nd of January, nineteen hundred and twenty-four, at 5 o'clock P. M., after regular notice sent to all members.

Among other resolutions, the following was unanimously adopted:
