

Security of public officer as guarantee for deputy. **"614a.** The security given by a public officer shall be a guarantee also of the actions and omissions of the deputy appointed by him before or after he has furnished such security.

Idem. **"614b.** Such security shall be a guarantee also of the actions and omissions of the deputy in the performance of the duties of his office, after the death or resignation of the officer who appointed him; nevertheless, the Lieutenant-Governor in Council may require, upon the death or resignation of a public officer, that the deputy appointed by the latter furnish new security."

Reservation. **2.** This act shall not affect the presently existing security of public officers.

Coming into force. **3.** This act shall come into force on the day of its sanction.

## CHAP. 18

An Act to amend the Revised Statutes, 1909, respecting Agents-General for the Province

[Assented to, the 15th of March, 1924]

**HIS MAJESTY**, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

S., 689, am. **1.** Article 689 of the Revised Statutes, 1909, as amended by the acts 9 George V, chapter 16, section 3, and 10 George V, chapter 19, section 1, is again amended by striking out, in the second line thereof, the words: "to the Agent-General for the Province in the United Kingdom".

V, c. 16, s. 6, am. **2.** Section 6 of the act 7 George V, chapter 16, as amended by the acts 9 George V, chapter 16, section 2; 10 George V, chapter 19, section 2, and 10 George V, chapter 20, section 1, is again amended by striking out, in the third line of the second paragraph thereof, the words: "the Agent-General for the Province in the United Kingdom".

**“712d.** The word “Agent-General”, used in the pre-“Agent-

**“712g.** If an Agent-General, after having continued Idem.  
in office for thirty years and become afflicted with some  
permanent infirmity disabling him from the due execution  
of his office, resigns his office, or is retired, His Majesty  
may, by letters patent under the Great Seal, grant him a  
pension equal to the salary of his office at the time of his  
resignation, or retirement; such pension to commence  
from the date of his retirement and to be paid to him during  
his life-time.

**“712h.** The Lieutenant-Governor in Council may, in Retirement  
and pension.

every case in which an Agent-General may send in his resignation and obtain a pension in accordance with the rules set out in articles 712*e*, 712*f* and 712*g*, retire such Agent-General and grant him the same pension as that to which he would have been entitled if he had sent in his resignation under any one of the said articles.

**"712*i*.** Nevertheless, in every case where an Agent-General may send in his resignation or be retired on pension in accordance with the provisions of articles 712*e*, 712*f* or 712*g*, the Lieutenant-Governor in Council may grant him a pension of five thousand dollars per annum, if he resigns within thirty days of a request by the Prime Minister for such resignation.

**"712*j*.** If any person, who receives a pension under the provisions of this section, receives a salary for filling any office under the Government of this Province, there shall be deducted from such salary an amount equal to the amount of his pension."

## CHAP. 19

### An Act respecting the bridge over the Montmorency River

[Assented to, the 15th of March, 1924]

**HIS MAJESTY**, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** The Quebec Public Service Commission may, at the request of any person, order whatever work it deems expedient for rebuilding, repairing or maintaining the vehicle bridge crossing the Montmorency River near its mouth, and, in each instance, indicate the person under whose direction the work is to be done. It may order that the bridge be reconstructed at the place where the present bridge is situated or at another place between the falls and the place where the present bridge stands.
