CHAP. 44

An Act to amend the Revised Statutes, 1909, respecting the protection of public buildings against fire

[Assented to, the 15th of March, 1924]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. Article 3789*h* of the Revised Statutes, 1909, as enacted by the act 11 George V, chapter 75, section 2, and amended by the act 13 George V, chapter 58, section 1, is again amended by replacing the second paragraph of paragraph 1 thereof, by the following paragraphs:

CHAP. 45

An Act to amend the law respecting the fire commissioner for the city of Montreal

1. Article 3821 of the Revised Statutes, 1909, as amend-

ed by the act 2 George V, chapter 35, section 1, is again amended by replacing the words: “five thousand dollars”, in the third line of the first paragraph thereof, by the words: “six thousand dollars”.

CHAP. 46

An Act to amend the act for the prevention of fires

[Assented to, the 15th of March, 1924]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. Article 3822j of the Revised Statutes, 1909, as R. S., 3822j, enacted by the act 3 George V, chapter 38, section 1, and ^{am.} amended by the acts 6 George V, chapter 26, section 1; 8 George V, chapter 52, section 1; 12 George V, chapter 71, section 1, and 13 George V, chapter 59, section 1, is again amended:

a. By replacing the words: “sixty thousand dollars”, in the second and third lines thereof, by the words: “one hundred thousand dollars”;

b. By adding, after the words: “or to town municipalities with a population of less than two thousand souls”, in the fourth line thereof, the following words: “or to rural municipalities”.

CHAP. 47

An Act to amend the Revised Statutes, 1909, respecting the medical staff of *l'Hôpital Saint-Michel-Archange*

[Assented to, the 15th of March, 1924]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The Revised Statutes, 1909, are amended by inserting R. S., 4090a, therein, after article 4090, the following article: ^{added.}
