

of such assessment, all the rights, powers and privileges of county attributed to it for the recovery of taxes from the other local municipalities of the county, and it may cause the judgments obtained against the city or town municipality to be executed, in conformity with the provisions of articles 811 and following of the Municipal Code.

**6.** This act shall come into force on the day of its sanction. Coming into force.

#### C H A P . 5 9

An Act to amend the Revised Statutes, 1909, respecting  
the early closing of stores

[Assented to, the 15th of March, 1924]

**H**IS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** Article 5885 of the Revised Statutes, 1909, is amended R. S., 5885, by replacing the word: "seven", in the eighth line thereof <sup>am.</sup> by the word: "six".

#### C H A P . 6 0

An Act to amend the Revised Statutes, 1909, respecting  
the width of streets in cities, towns and villages

[Assented to, the 15th of March, 1924]

**H**IS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** Section third of chapter second of title eleventh of the Revised Statutes, 1909 (articles 5887 and 5888), is re-5888, re- placed by the following section and articles: placed.

"SECTION III

"WIDTH OF ROADS AND STREETS IN CITIES, TOWNS  
AND VILLAGES

**"5887.** In cities, towns and village municipal ties, no Width of

streets in cities, towns and villages. matter what law governs them, the roads and streets shall have a width of at least sixty-six feet, English measure.

When land divided into building lots. **"5887a.** Any person, corporation, company or partnership which divides its land into building lots shall, for the roads and streets it marks out on the land, allow a width of at least sixty-six feet, English measure.

Prior submission and approval of plan. A plan of the division of the land marking out the proposed roads or streets shall be submitted to the municipal council, and the work of opening up streets and dividing the land into building lots shall not be commenced until the council has approved the position of the roads or streets proposed to be opened on such land.

Approval only where required width. Saving in the case of article 5887b, the municipal council shall grant its approval only if the roads or streets marked on the plan have a width of sixty-six feet, English measure.

Exception. **"5887b.** The municipal council may obtain from the Lieutenant-Governor in Council, in special and exceptional cases, permission to open and maintain, or to allow to be opened and maintained, a street or road of width less than sixty-six feet, English measure.

Injunction by proprietor. **"5887c.** Any proprietor who is a municipal elector may take action, by means of injunction, against the municipality or person contravening this section, and in such case articles 957 to 972 of the Code of Civil Procedure shall apply.

Id., by municipality. **"5887d.** The municipality shall have the same recourse against any person who, in dividing his land into building lots, lays out or opens roads or streets without the approval required by article 5887a, or having obtained such approval, lays out or opens roads or streets on his land in contravention of the provisions of this section.

Where not applicable. **"5887e.** This section shall not apply to the cities of Quebec and Montreal nor, in the other city, town or village municipalities, to roads and streets already opened or laid out before the fifteenth day of March, 1924.

In the case of new municipalities. **"5888.** In new city, town or village municipalities, erected after the fifteenth day of March, 1924, it is permissible to leave and maintain the roads and streets then open or laid out at the width given to them according to the law governing the municipal territory before its erection into a city, town or village municipality."

Coming into force. **2.** This act shall come into force on the day of its sanction.
