

## C H A P . 61

## An Act to amend the Quebec Companies' Act, 1920

[Assented to, the 15th of March, 1924]

**H**IS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** Article 5968 of the Revised Statutes, 1909, as enacted R. S., 5968, by the act 10 George V, chapter 72, section 1, is amended <sup>am.</sup> by replacing the word: "reciting", in the ninth line thereof by the word: "amending".

**2.** Form "I" of the Quebec Companies' Act, 1920, as <sup>Que. Co's,</sup> enacted by the act 10 George V, chapter 72, section 1, is <sup>Act, 1920,</sup> amended by striking out, in the ninth, tenth and eleventh <sup>Form I, am.</sup> lines, the words: "for the following purposes (*here give the tenor of the original letters patent, mentioning all details, including the capital and the head office.*)".

**3.** Article 5969 of the Revised Statutes, 1909, as enacted R. S., 5969, by the act 10 George V, chapter 72, section 1, is amended <sup>am.</sup> by replacing the word: "reciting", in the fourth line thereof, by the word: "amending".

**4.** Paragraph 2 of article 6085 and its sub-paragraphs R. S., 6085, *a, b, c, d and e*, as enacted by the act 10 George V, chapter <sup>am.</sup> 72, section 1, are replaced by the following:

"2. The application shall be accompanied by a memorandum of agreement, in duplicate; such document may be drawn up in the form Q."

**5.** Form "Q" of the Quebec Companies' Act, 1920, as <sup>Que. Cos'.</sup> enacted by the act 10 George V, chapter 72, section 1, is <sup>Act, 1920,</sup> amended by striking out the second paragraph of the form, <sup>Form Q, am.</sup> beginning with the words: "And we do hereby severally agree to become members".

**6.** Article 6086 of the Revised Statutes, 1909, as enacted R. S., 6086, by the act 10 George V, chapter 72, section 1, is repealed. <sup>repealed.</sup>

**7.** Article 6088c of the Revised Statutes, 1909, as enacted R.S., 6088c, by the act 10 George V, chapter 72, section 1, is amended <sup>am.</sup> by replacing the words and numbers: "paragraphs 1 and 2 of 5963;" in the fifth line thereof, by the words and number: "the second paragraph of 5963;"

Coming into force. **8.** This act shall come into force on the day of its sanction.

C H A P . 62

An Act to amend the Revised Statutes, 1909, and the Civil Code, respecting partnership and other declarations

[Assented to, the 15th of March, 1924]

**H**IS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

R. S., 6091, am. **1.** Article 6091 of the Revised Statutes, 1909, is amended:

a. By replacing the word: "sixty", in the fourth line of paragraph 3 thereof, by the word: "fifteen";

b. By replacing the word: "sixty", in the fourth line of paragraph 4 thereof, by the word: "fifteen".

R. S., 6095, am. **2.** Article 6095 of the Revised Statutes, 1909, as amended by the act 1 George V (1910), chapter 33, section 1, is again amended by replacing the word: "sixty", in the second line thereof, by the word: "fifteen".

R. S., 7437, am. **3.** Article 7437 of the Revised Statutes, 1909, is amended by replacing the word: "sixty", in the first line of paragraph 4 thereof, by the word: "fifteen".

R. S., 7439, am. **4.** Article 7439 of the Revised Statutes, 1909, is amended by replacing the word: "sixty", in the first line of paragraph 2 thereof, by the word: "fifteen".

C. C., art. 1834, am. **5.** Article 1834 of the Civil Code, as amended by the act 2 Edward VII, , chapter 38, section 1, is again amended:

a. By replacing the word: "sixty", in the fifth line of the third paragraph thereof, by the word: "fifteen";

b. By replacing the word: "sixty", in the sixth line of the third paragraph thereof, by the word: "fifteen".

Coming into force. **6.** This act shall come into force on the day of its sanction.
