

## C H A P . 66

An Act to amend the Revised Statutes, 1909, respecting insurance.

[Assented to, the 15th of March, 1924]

**H**IS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** Article 6837 of the Revised Statutes, 1909, is amended R. S., 6837, by replacing the words and number: “(article 6002 and fol-<sup>am.</sup> lowing)”, in the second line of paragraph 6 thereof, by the the words and numbers: “1920, (articles 5957*a* to 6040)”.

**2.** Article 6838 of the Revised Statutes, 1909, is amend- R. S., 6838, ed: <sup>am.</sup>

*a.* By adding thereto, after the words: “and accident”, in the second line of paragraph 1 thereof, the words: “or sickness and accident”;

*b.* By adding thereto, after the word: “insurance”, in the third line of the said paragraph 1 thereof, the words: “or any other class or classes of insurance not provided for in the following paragraphs”;

*c.* By adding thereto, after the word: “vehicles”, in the second line of paragraph 2 thereof, the words “or marine insurance”;

*d.* By adding thereto, after the word: “insurance”, in the second line of paragraph 4 thereof, the words: “or automobile insurance or aviation insurance”.

**3.** Article 6923 of the Revised Statutes, 1909, as amend- R. S., 6923, ed by the act 4 George V, chapter 54, section 5, is again <sup>am.</sup> amended by adding thereto, after sub-paragraph *h* of paragraph 4 thereof, the following sub-paragraph:

*i.* For every insurance company carrying on the business of marine insurance, not being registered or licensed for any other class of business and having no deposit with the Provincial Treasurer, or with the Minister of Finance at Ottawa, twenty-five thousand dollars”.

**4.** Article 6941 of the Revised Statutes, 1909, as amend- R. S., 6941, ed by the act 1 George V (2nd session), chapter 44, section <sup>am.</sup> 2, is further amended:

*a.* By replacing the words and numbers: “111 to 126 of the Insurance Act, 1910, of Canada”, in the first and se-

cond lines of paragraph 3 thereof, by the words and numbers: "106 to 116 of the Insurance Act, 1917, of Canada";

*b.* By replacing the words: "of paragraphs (1) and (3) of section 3 or of paragraph 5 of section 20 of the said Insurance Act, 1910," in the second and third lines of paragraph 5 thereof, by the words: "of section 3 or of paragraph 5 of section 20 of the Insurance Act, 1917, of Canada".

am. **5.** Article 6960*k* of the Revised Statutes, 1909, as enacted by the act 7 George V, chapter 46, section 1, and replaced by the act 8 George V, chapter 66, section 1, is amended by adding thereto, after the word: "only", in the seventh line thereof, the words: "or sickness and accident insurance only, or credit insurance only:".

am. **6.** Article 6978 of the Revised Statutes, 1909, as amended by the act 1 George V (2nd session), chapter 44, section 5, is again amended:

*a.* By striking out the words: "with the exception of those mentioned in paragraphs 1 and 2 of article 6941", in the third and fourth lines of paragraph 1 thereof;

*b.* By replacing the words: "such reports", in the second line of the first paragraph of paragraph 3 thereof, by the words: "the reports of all provincial companies or associations".

am. **7.** Article 6979 of the Revised Statutes, 1909, is amended:

*a.* By striking out the words: "save those excepted by article 6978", in the first and second lines thereof;

*b.* By replacing the words: "Provincial Treasurer", in the third and fourth lines thereof, by the words: "Superintendent of Insurance".

R. S., 6984*a*,  
enacted. **8.** The Revised Statutes, 1909, are amended by inserting therein, after article 6984, the following article:

Increase or  
decrease of  
directors.

**"6984*a*.** Any company incorporated under this section or any special act may, by by-law, increase, or decrease to not less than five, the number of its directors, but no such by-law shall be valid or acted upon, unless it is approved by a vote of at least two-thirds in value of the stock represented by the shareholders present at a special general meeting called for considering the by-law, nor until a copy of such by-law, certified under the seal of the company, has been deposited with the Superintendent of Insurance, and has also been published in the *Quebec Official Gazette*."

**9.** Article 7031 of the Revised Statutes, 1909, is amended R. S., 7031, am. by replacing paragraph 1 thereof by the following:

**“7031.** 1. No company or association shall insure the Insurance life of a child under ten years of age in any sum, or pay on children on the death of a child under ten years of age any sum, which under ten alone or together with any sum payable on the death of years. the child by any other company or association exceeds the following sums respectively:

C H A P . 67

An Act to amend the Quebec Insurance Act respecting funeral insurance

[Assented to, the 15th of March, 1924]

**HIS MAJESTY**, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** Article 7031*i* of the Revised Statutes, 1909, as enacted R. S., 7031*i*, am. by the act 7 George V, chapter 47, section 1, is amended by replacing the words: “the district”, in the fourth line of the last paragraph thereof, by the words: “the island”.
