

## C H A P. 116

An Act to provide for the transfer by the Montreal Maternity of all its property, assets and rights to the Royal Victoria Hospital of Montreal

[Assented to, the 15th of March, 1924]

Preamble. **W**HEREAS the Montreal Maternity has by its petition represented:

That the Montreal Maternity was incorporated under and by virtue of a special statute of the Province of Canada, 1854 (18 Victoria, chapter 61), as amended by statutes of the Province of Quebec in 1884 (47 Victoria, chapter 61) and 1887 (50 Victoria, chapter 36) and 1905 (5 Edward VII, chapter 95);

That the Royal Victoria Hospital, a general hospital of the city of Montreal in the Province of Quebec, was incorporated in 1887 by special statute of the Dominion Parliament (50-51 Victoria, chapter 125), and is a large and important hospital in full and permanent operation in the city of Montreal;

That the Montreal Maternity is desirous of transferring to the Royal Victoria Hospital all the immoveable property and all the moveables, rights and privileges of whatsoever nature of the Montreal Maternity;

That the Royal Victoria Hospital is ready and willing to accept that transfer;

That it is in the interests of the Montreal Maternity and of the city of Montreal and the surrounding country that the Montreal Maternity should make that transfer, because the Royal Victoria Hospital will be better able to furnish the important services and opportunities to the city of Montreal and the surrounding country than the Montreal Maternity is able to do in view of the present size of the city of Montreal and all the circumstances;

Whereas it is expedient to grant said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Transfer authorized.

**1.** The Montreal Maternity is hereby authorized and empowered to assign and transfer to all intents and purposes unto the Royal Victoria Hospital all the property, moveable and immoveable, and all the moveables and rights of whatever nature of the Montreal Maternity, and all the capital assets of the Montreal Maternity, however acquired, as well as the right to all its revenues, the whole

subject to the conditions and restrictions upon which such

property or rights were acquired by the Montreal Maternity, subject to the discharge of all its liabilities.

**2.** The Royal Victoria Hospital is hereby authorized and empowered to accept the said assignments and transfers to all intents and purposes and to take, hold, possess, use and dispose of all immoveable property and all the moveables and rights of whatever nature so assigned and transferred.

Power to accept transfer, authorized.

**3.** This act shall come into force on the day of its sanction.

## C H A P. 117

An Act to amend the act to consolidate the charter of the Notre-Dame Hospital, Montreal, and its amendments

[Assented to, the 15th of March, 1924]

**W**HEREAS the Notre-Dame Hospital, a benevolent corporation of the city of Montreal, was incorporated by the act 44-45 Victoria, chapter 48, and the amendments thereto: the acts 61 Victoria, chapter 82; 2 Edward VII, chapter 97, and 7 Edward VII, chapter 121, has, by its petition, prayed that certain amendments be made to its charter so as to amend its constitution and more clearly define its powers, as well as to grant it certain additional powers; and

Preamble.

Whereas it is expedient to grant the prayer contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** Section 1 of the act 61 Victoria, chapter 82, is replaced by the following section:

61 Viet., c. 82, s. 1, replaced.

**1.** The incorporation of the Notre-Dame Hospital, except as otherwise provided in the present act, is confirmed with all rights, powers and privileges, granted by the statutes mentioned in the preamble to this act, and, in particular, it has the right to establish, maintain and administer a hospital with branches and annexes in the city of Montreal and in the Province of Quebec. The said corporation has had in the past and shall have the right to acquire, receive, hold, possess and use all immoveable property, and all money or moveable property which may have been or may be hereafter given, granted, purchased, appropriated,
