

To give aid to persons applying for the same on account of accident;

To give instruction respecting medicine, surgery, and nursing of the sick;

The establishment or acquisition and the management of houses for incurables or the infirm, or sanatoria for the treatment of tuberculosis or other diseases, or convalescent homes or institutions of the same kind;

To train nurses and maternity assistants, grant them diplomas or certificates of competence as such, after the fulfilment of the formalities and conditions required by the by-laws therefor."

C H A P. 121

An Act to incorporate *La Crèche St-Vincent-de-Paul*

[Assented to, the 15th of February, 1924]

WHEREAS Dames Marie-Anna Loignon, in religion Preamble.

Marie de Saint-Pierre-Damien; Azilda Lajoie, in religion Marie de Sainte-Augustine; Lydia Paradis, in religion Marie de Saint-Thomas; Edith Hearn, in religion Marie de Saint-Patrice de Jésus; Marie-Ange Létourneau, in religion Marie du Cœur Immaculé; all five of *La Congrégation des Sœurs Servantes du Cœur Immaculé de Marie*, called "The Good Shepherd's Asylum of Quebec", duly incorporated by the act 18 Victoria, chapter 233, and amendments thereto, and respectively superioress, assistant, counsellor, *économe* and secretary of the institution commonly known by the name of *La Crèche St-Vincent-de-Paul*, have, by their petition, represented:

That for the sake of the better development of their institution, and in order to devote thereto all their resources obtained from the generosity of the public, it is necessary to create them a distinct corporation;

That the petitioners have obtained the consent of His Eminence the Cardinal Archbishop of Quebec;

That the Council of the *Sœurs Servantes du Cœur Immaculé de Marie*, called The Good Shepherd's Asylum of Quebec, has also given its consent, on the condition that the new corporation shall assume all the obligations in relation

to such institution, to the entire discharge of *La Congrégation des Sœurs Servantes du Cœur Immaculé de Marie*, called The Good Shepherd's Asylum of Quebec; and

Whereas it is expedient to grant the prayer of the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Incorporation.

1. The superioress, the assistant, the *économé*, the counsellor and the secretary of the institution commonly known under the name of *La Crèche St-Vincent-de-Paul*, and their successors as superioress, assistant, *économé*, counsellor and secretary, appointed to such offices by the council of *La Congrégation des Sœurs Servantes du Cœur Immaculé de Marie*, called The Good Shepherd's Asylum of Quebec, are hereby incorporated under the name of *La Crèche St-Vincent-de-Paul*.

Name.

Corporate seat.

2. The corporate seat of the corporation shall be in the city of Quebec.

Powers of corporation.

3. The corporation shall have the powers, rights and privileges pertaining to ordinary civil corporations, and it may:

- a. Have a common seal and alter it at will;
- b. Appear before the courts;
- c. Accept, acquire and possess, according to law, rights, moveables and immoveables, provided the annual revenue from the immoveables belonging to the corporation and possessed by it, for revenue purposes, does not exceed one hundred thousand dollars;
- d. Administer such property and draw the revenues thereof, rent, sell, exchange, cede and alienate the same in any way whatsoever, or otherwise dispose of same;
- e. Borrow money on the credit of the corporation;
- f. Issue bonds or other securities of the corporation and give the same in guarantee or sell them at the price and amount considered advisable;
- g. Hypothecate, mortgage or pledge the immoveables of the corporation to assure the payment of such bonds or other securities or give a part only of these guarantees for the same object; and constitute the hypothec, mortgage or pledge mentioned in this sub-paragraph by a deed of trust or in any other way;
- h. Hypothecate or mortgage the immoveables to assure the payment of loans made otherwise than by bond issue as well as the payment or execution of other debts, contracts or undertakings of the corporation;

i. Adopt, for its organization and management, for the administration of its property and the disposal of its funds, and generally for all purposes cognate to its object, for the realization of its undertaking, for the carrying out of its aims and the exercise of its powers, the by-laws and orders which it may think proper, provided they contain nothing contrary to the laws of this Province.

4. By an agreement between the corporation and *La Cession of*
Congrégation des Sœurs Servantes du Cœur Immaculé de Marie, called The Good Shepherd's Asylum of Quebec, ap-
proved by His Grace the Archbishop of Quebec, the cor-
poration may cede all its moveables and immoveables to
the said congregation, which latter shall assume all the
debts and obligations of the corporation, and, from the
date of such cession, the corporation shall cease to exist.

5. The corporation shall transmit to the Lieutenant-Governor in Council, annually in the month of January, and whenever thereunto required, a statement of the property held by the corporation, the names of its officers and a copy of its rules and by-laws.

6. This act shall come into force on the day of its sanction.

C H A P. 122

An Act to incorporate *La Corporation de Notre-Dame du Chemin*

[Assented to, the 15th of February, 1924]

WHEREAS the Reverend Fathers Léonidas Hudon, Joseph-Papin Archambault, Louis Héroux, Hugues Lefebvre and Léon Sigouin, all members of the Society of Jesus, and of the city and district of Quebec, have, by their petition, prayed to be incorporated for religious and educational purposes and for the carrying on of charitable and social undertakings, under the name of *La Corporation de Notre-Dame du Chemin*; and

Whereas it is expedient to grant the said prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The Reverend Fathers Léonidas Hudon, Joseph-Papin Archambault, Louis Héroux, Hugues Lefebvre and
