

i. Adopt, for its organization and management, for the administration of its property and the disposal of its funds, and generally for all purposes cognate to its object, for the realization of its undertaking, for the carrying out of its aims and the exercise of its powers, the by-laws and orders which it may think proper, provided they contain nothing contrary to the laws of this Province.

4. By an agreement between the corporation and *La Cession of*
Congrégation des Sœurs Servantes du Cœur Immaculé de Marie, called The Good Shepherd's Asylum of Quebec, ap-
proved by His Grace the Archbishop of Quebec, the cor-
poration may cede all its moveables and immoveables to
the said congregation, which latter shall assume all the
debts and obligations of the corporation, and, from the
date of such cession, the corporation shall cease to exist.

5. The corporation shall transmit to the Lieutenant-Governor in Council, annually in the month of January, and whenever thereunto required, a statement of the property held by the corporation, the names of its officers and a copy of its rules and by-laws.

6. This act shall come into force on the day of its sanction.

C H A P. 122

An Act to incorporate *La Corporation de Notre-Dame du Chemin*

[Assented to, the 15th of February, 1924]

WHEREAS the Reverend Fathers Léonidas Hudon, Joseph-Papin Archambault, Louis Héroux, Hugues Lefebvre and Léon Sigouin, all members of the Society of Jesus, and of the city and district of Quebec, have, by their petition, prayed to be incorporated for religious and educational purposes and for the carrying on of charitable and social undertakings, under the name of *La Corporation de Notre-Dame du Chemin*; and

Whereas it is expedient to grant the said prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The Reverend Fathers Léonidas Hudon, Joseph-Papin Archambault, Louis Héroux, Hugues Lefebvre and

Léon Sigouin, all members of the Society of Jesus, of the city of Quebec, and all persons who may hereafter become members of the corporation, in accordance with its constitution and by-laws, are hereby incorporated, for religious and educational purposes, and for the carrying out of charitable and social undertakings, under the name of *La Corporation de Notre-Dame du Chemin*.

Name.

Corporate seat.

2. The corporate seat of the corporation shall be at Quebec, and it shall have perpetual succession.

Powers, rights and privileges.

3. The corporation may perform all the acts and enter into all contracts necessary for the attainment of the object for which it was incorporated, and it shall have the powers, rights and privileges pertaining to ordinary civil corporations in the Province of Quebec, such as, to:

a. Have a common seal and alter it at will;

b. Appear before the courts;

c. Accept, receive and acquire, according to law, and possess moveables and immoveables, provided the annual revenue from the immoveables held by the corporation, for purposes of revenue only, does not exceed one hundred thousand dollars;

d. Administer such property and draw the revenues thereof, sell, exchange, cede and alienate the same in any way whatsoever, or otherwise dispose of same;

e. Contract, in any manner recognized by law, on the credit of the corporation, loans of any sum of money necessary for the attainment of the objects for which it was incorporated;

f. Issue bonds or other securities of the corporation, and sell, exchange, mortgage or pledge the same;

g. Hypothecate, mortgage or pledge the property of the corporation, as security for the payment of its loans, bonds and securities and the performance of its contracts and obligations, and in respect thereof to exercise all the rights, powers and privileges vested in joint stock companies by sub-paragraphs *b*, *c* and *d* of paragraph 1 of article 6056f of the Quebec Companies Act, 1920;

h. Adopt by-laws, orders and regulations necessary for its organization, management and government; for the permanence of its existence; for the administration of its property and the disposal of its funds; for the realization of its undertaking, and, generally, for the carrying out of its aims and the exercise of its powers.

Statement transmitted to Lt.-Gov. in C.

4. The corporation shall transmit to the Lieutenant-Governor in Council, annually in the month of January, and whenever thereunto required, a statement of the property

held by the corporation, the names of its officers and a copy of its rules and by-laws.

5. The Reverend Fathers Léonidas Hudon, Joseph-Papin Archambault, Louis Héroux, Hugues Lefebvre and Léon Sigouin, all members of the Society of Jesus, hereinabove mentioned, shall be a provisional board of management in charge of the exercise of all the powers and rights of the corporation until the organization of the corporation is provided for by the by-laws and regulations to be adopted.

6. In the case of dissolution or extinction of the corporation, its affairs shall be liquidated in the manner provided by the laws in force; and, its debts paid, its surplus assets, if any, to return to the Society of Jesus, incorporated by the Quebec statute, 50 Victoria, chapter 28.

7. This act shall come into force on the day of its sanction.

C H A P. 123

An Act to amend the charter of *Les Révérends Pères du Très-Saint-Sacrement de Québec*

[Assented to, the 15th of February, 1924]

WHEREAS *Les Pères du Très-Saint-Sacrement de Québec*, incorporated by the act 11 George V, chapter 155, have, by their petition, and with the consent of His Eminence the Cardinal Archbishop of Québec, prayed for the passing of an act to amend the above mentioned act, in such a way as to dispense with certain consent required and certain control established by the said act; to replace section 5 of the said act by another which will give effect to appointments by the Superior-General of *Les Pères du Très-Saint-Sacrement*; and to settle in a different way what shall take place in case of dissolution of the corporation;

Whereas it is expedient to grant the prayer of the petitioners;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Québec, enacts as follows:

1. Paragraph *b* of section 4 of the act 11 George V, chapter 155, is replaced by the following:

“*b.* have and exercise all the rights, powers and privileges of ordinary civil corporations;”
