An Act to incorporate The Congregation Tifereth Joseph
of Amherst Park

[Assented to, the 15th of March, 1924]

WHEREAS George Rosenbloom, president; Isaac Cohen, Preamble.
vice-president; Solomon Chaikin, secretary; Jacob Pinsky, treasurer; M. Novak, Rev. Samuel Richler, Mike Bernstein, Sam Rosenfeld, B. Rosenzweig, Abraham Vineberg, Wolf Barkin, Moe B. Levitt, Samuel Daskoff, Borru Ostrofsky, Solomon Gitlitz, Jacob Icatch, Peter Singerman, Solomon Koufman, B. Goodman, Max Aikman, Sam Novak, Victor Novak, L. Nipom, Jacob Cohen, Z. Cohenn, J. Richler, M. Schlein, Bella Singerman, Bella Cohen, Mollie Richler, Bessie Novak, all of the city and district of Montreal, have by petition set forth that they are persons professing the Jewish religion and are desirous of incorporating themselves and such others as may hereafter become members into a religious congregation under the name "The Congregation Tifereth Joseph of Amherst Park", and whereas it is expedient to grant their prayer;

Whereas certain properties are now held in trust for said congregation by Solomon Gitlitz, Solomon Chaikin, Isaac Cohen and Samuel Richler, and it is desirable that said properties should be vested in the new corporation to be hereby created under the name of "The Congregation Tifereth Joseph of Amherst Park";

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Schlein, Bella Cohen, Bella Singerman, Mollie Richler and Bessie Novak, all of the city and district of Montreal and all other persons who now are and may hereafter become members are hereby constituted a body corporate and politic under the name of "The Con-^{Name.}
gregation Tifereth Joseph of Amherst Park".

2. All the property, moveable and immoveable, now Property

vested in congregation.

possessed or held in trust for the said congregation by Solomon Gitlitz, Solomon Chaikin, Isaac Cohen and Samuel Richler, shall be and is hereby transferred to and vested in the said congregation and the said congregation shall be responsible for all liabilities contracted by it.

Power to acquire etc., immoveable property.

3. The said corporation may at all times acquire, sell, lease, exchange, hypothecate, and alienate its immoveable property or any part of it, and acquire in its place and stead other immoveable property, and the said corporation shall have the power, for its own purposes, to make, draw, accept, endorse and transfer bills of exchange, promissory notes, cheques, bonds and other negotiable documents and instruments under the signature of its officers and others in its corporate name, as shall be determined by the by-laws of the said corporation.

Power to have a synagogue, etc.,

4. The said corporation may have, hold and possess and may acquire by purchase, gift, will or otherwise, any immoveable property, in and near the city of Montreal, that may be required for a synagogue or place of worship, or for a house for the residence of the rabbi or officiating minister, or for a cemetery, or burial ground, or for any other purpose of the said corporation; provided always that the use of any lands for a cemetery shall be subject to the laws respecting cemeteries and that such cemetery shall not be established in any municipality without having first obtained the consent of the said municipality, expressed by by-law, and provided further that the immoveable property held by the said corporation shall not exceed in annual value the sum of forty thousand dollars.

Immoveable property exceeding authorized amount.

5. In the event of the said corporation receiving by gift, or will, any immoveable property in excess of that which it is hereby authorized to possess, the said gift or legacy shall not on that account be void, but the said corporation shall be bound, within five years from the date of its entering into peaceable possession of the said gift or legacy, to sell and dispose of the said immoveable property or part of it, or some other of its immoveable property or part of it, in such manner that the immoveable property of the said corporation shall not exceed in annual value the sum of forty thousand dollars.

Registers for acts of civil status.

6. The said corporation may from time to time appoint a rabbi or officiating minister, and may remove him and appoint another or others in his place, and the rabbi or officiating minister of the said corporation is hereby authorized and empowered to keep, in the English or French

language, registers for acts of civil status, and to exercise in that respect all other civil powers appertaining to ministers of religious congregations.

7. The said congregation is authorized to make by-laws ^{Power to} for its internal government and for the government and ^{make by-} discipline of its members, to amend or repeal said by-laws ^{laws.} or any part of them as may be expedient, provided always that none of such by-laws be inconsistent with this act or with the laws of this Province.

8. Nothing in this act shall prevent the provisions of ^{Provisions} the charter, regulations and by-laws of any municipality ^{applicable.} where the corporation may exercise its powers from applying to the said corporation, nor the provisions of the Quebec Public Health Act.

9. The act of the late Province of Lower Canada ⁹⁻¹⁰ George IV, chapter 75, shall not apply to the members and ^{Provisions} officiating minister of the said congregation. ^{not appli-} ^{icable.}

10. The corporation shall transmit to the Lieutenant- ^{Statement} Governor in Council, annually in the month of January, ^{forwarded} and whenever thereunto required, a statement of the pro- ^{to Lt.-Gov.} perty held by the corporation, the names of its officers, ^{in C.} and a copy of its rules and by-laws.

11. This act shall come into force on the day of its ^{Coming into} sanction. ^{force.}

C H A P. 135

An Act to incorporate The Jewish Home for Aged of Montreal

[Assented to, the 15th of March, 1924]

WHEREAS the persons, hereinbelow mentioned, have, ^{Preamble.} by their petition, respectfully desired to constitute themselves, and others who may subsequently become members thereof, a corporation for the purpose of establishing and maintaining in the city of Montreal, a home for the care, maintenance and placing of aged persons professing the Hebrew religion, and to generally give to such aged persons of both sexes, all the care, protection and assistance necessary for their proper maintenance;

Whereas it is necessary and desirable in the interest of
