

C H A P. 154

An Act to authorize the College of Physicians and Surgeons
of the Province of Quebec to admit Léopold Adolphe
Girard to the practice of medicine, surgery and
obstetrics

[Assented to, the 15th of February, 1924]

Preamble.

WHEREAS Léopold Adolphe Girard, of the city of
Montreal, in the province of Quebec, physician, has,
by his petition, represented:

That he has obtained from Wisconsin Medical University,
in the city of Milwaukee, in the State of Wisconsin, one of
the United States of America, a degree as Doctor of Medi-
cine, after having duly followed the course in the said
university;

That for about ten years he has practised medicine, sur-
gery and obstetrics, in the city of Springfield, in the State
of Massachusetts, one of the United States of America, and
for about twenty years in the city of Biddeford, in the
State of Maine, one of the United States of America;

That he possesses all the qualifications required for the
practice of medicine, surgery and obstetrics;

That he is unable to obtain his license for the practice
of medicine, surgery and obstetrics in the Province of
Quebec, without special authorization by the Legislature;

That he has obtained the consent of the College of Phy-
sicians and Surgeons of the Province of Quebec for the
passing of an act to authorize the said College to grant
him the license required for the practice of his profession
in the Province of Quebec, after examination on internal
and external pathology, materia medica and all the exam-
inations of the fifth year;

Whereas the petitioner has prayed for an act to that
effect; and

Whereas it is expedient to grant his prayer;

Therefore, His Majesty, with the advice and consent of
the Legislative Council and of the Legislative Assembly of
Quebec, enacts as follows:

L. A. Girard
admitted to

1. The College of Physicians and Surgeons of the Prov-
ince of Quebec is authorized to admit, among its members,
the said Léopold Adolphe Girard, and to grant him the
license required for the practice of medicine, surgery and
obstetrics in the Province of Quebec, after he shall have
passed the examinations on internal and external patho-
logy, materia medica and all the examinations of the fifth
year.

2. This act shall come into force on the day of its sanction. Coming into force.

C H A P. 155

An Act to authorize the College of Physicians and Surgeons of the Province of Quebec to admit Vincent P. Heney to the practice of medicine and surgery, after examination

[Assented to, the 15th of February, 1924]

WHEREAS Vincent P. Heney, of the city and district of Preamble. Ottawa, has, by his petition, represented:

That he was admitted to McGill University and has attended the said university and followed a medical course for the time required to complete such course;

That, in 1923, the said McGill University granted him the degree of Doctor in Medicine;

That he is desirous of practising his profession of medicine and surgery in the Province of Quebec;

That although he has fulfilled all the other requirements he did not register with the College of Physicians and Surgeons of the Province of Quebec at the time of his entrance upon his studies, which fact prevents him from practising his profession in this Province unless he is granted a special license authorizing him to do so;

That after due consideration the College of Physicians and Surgeons of the Province of Quebec has consented to the passing of an act for a license to practise medicine and surgery, after passing the medical examination required before the board of examiners of the said College;

That a certificate of the said College of Physicians and Surgeons of the Province of Quebec was filed with his petition;

Whereas the petitioner has prayed for an act to the effect that he be permitted to practise medicine and surgery after passing the medical examination required for a license before the board of examiners of the College of Physicians and Surgeons of the Province of Quebec; and

Whereas it is expedient to grant his prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The College of Physicians and Surgeons of the Province of Quebec is authorized to admit the said Vincent P. Heney amongst its members, and to grant him the necessary V. P. Heney admitted to practice,
