An Act to authorize the College of Dental Surgeons of the
Province of Quebec to admit Thomas Edwin Burton
among its members

[Assented to, the 15th of February, 1924]

WHEREAS Thomas Edwin Burton, of the town of Preamble.
Cookshire, in the district of Saint Francis, Doctor
of Dental Surgery, has, by his petition, represented:

That in 1915, he completed his second year in Arts, at
Bishop's University, Lennoxville, and, in the fall of 1915,
instead of taking up his third year he enlisted in the 117th
Battalion, and went overseas, where he remained in active
service until after the armistice;

That, after his return and discharge, he entered McGill
University as a student in the faculty of dentistry, and
completed his course in May, 1923, graduating with the
degree of Doctor of Dental Surgery;

That he was admitted to the study of dental surgery on
the 13th of June, 1921, only;

That in June, 1922, he was granted a degree of Bachelor
in Arts by the university of Bishop's College at Lennox-
ville;

That he has passed his final examination before the
College of Dental Surgeons of the Province of Quebec, and
has complied with all the requirements of the said College;

That he could not be admitted to practise in his own
name on account of the delays caused to his admission to
study until the month of June, 1925, unless some relief is
granted him;

That the Board of Governors of the College of Dental
Surgeons of the Province of Quebec has consented to the
passing of an act to authorize the College of Dental Sur-
geons of the Province of Quebec to admit the said Thomas
Edwin Burton among its members, and to permit him to
practise the profession of dentist after the final examina-
tion for the practice of his profession;

That, by his studies and his experience, he has acquired
the necessary knowledge and title to the admission to the
practice of dental surgery, and to the exercise of the said
profession;

Whereas it is expedient to grant the prayer contained
in the said petition;

Therefore, His Majesty, with the advice and consent of
the Legislative Council and of the Legislative Assembly of
Quebec, enacts as follows:

T. E. Burton admitted to practice, after examination. **1.** The College of Dental Surgeons of the Province of Quebec is authorized to admit the said Thomas Edwin Burton among its members, and to grant him the license required to practise dental surgery in the Province, after examination.

Coming into force. **2.** This act shall come into force on the day of its sanction.

C H A P. 160

An Act to authorize the College of Dental Surgeons of the Province of Quebec to admit Joseph Delaney Maher among its members

[Assented to, the 15th of March, 1924]

Preamble. **W**HEREAS Joseph Delaney Maher, of the city of St. John, New Brunswick, has, by his petition, represented:

That he is authorized to practise dentistry in the Province of New Brunswick and in the Province of Nova Scotia, since the year 1899;

That he received the degree of Doctor of Dental Surgery from the Dental College of Boston, in the State of Massachusetts, one of the United States of America, in the month of June, 1889;

That he received a degree from the College of Dental Surgery of Chicago, in the State of Illinois, one of the United States of America, in the month of October, 1893;

That he was authorized to practise dental surgery in the State of Massachusetts, one of the United States of America, in the month of December, 1915;

That he is a duly registered dentist of the University of the State of New York, one of the United States of America;

That he has taken a course of study at St. Mary's College and at St. Laurent College, in the Province of Quebec;

That, since the year 1899, he has always practised dentistry in the city of St. John, N. B.;

That, by reason of his studies, his experience, and the part he has taken at various dental conventions, he possesses the knowledge necessary for the practice of the profession of dentistry, and is qualified to practise the said profession;

That he is returning to live in the Province of Quebec, and is desirous of being admitted as a member of the College of Dental Surgeons of the Province of Quebec;

That he has obtained the consent of the College of
