Whereas it is expedient to grant the prayer contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** The College of Dental Surgeons of the Province of J. D. Maher Quebec is authorized to admit Joseph Delaney Maher admitted to among its members, and to grant him the necessary license practice, after exam- for the practice of dental surgery in the Province of Quebec, ination. after the final examination.

#### C H A P. 161

An Act to authorize the College of Dental Surgeons of the Province of Quebec to admit J. Cyril Flanagan to the practice of dental surgery

[Assented to, the 15th of February, 1924]

**W**HEREAS J. Cyril Flanagan, of the city and district Preamble. of Montreal, Doctor of Dental Surgery, has, by his petition, represented:

That in May, 1916, he passed the matriculation examinations required for admission as student in dental surgery of McGill University of Montreal;

That immediately after having successfully passed these examinations he voluntarily enlisted in the Canadian Expeditionary Forces and he was on active service until he returned to Canada on January 19th, 1919, as medically unfit as the result of wounds suffered whilst serving at the front;

That, until the fall of 1919, he was under medical treatment and at that time took advantage of the offer made by the Board of Soldiers' Civil Re-establishment to obtain his first year's tuition in dental surgery at McGill University at their expense, and, for this and other unavoidable reasons, was unable to present himself for passing examinations for admission to the study of the said profession;

That he continued his studies at the said university

during a regular course of four years, and on October 5th, 1923, the said university granted him a diploma of Doctor of Dental Surgery;

That, by his studies and his experience, he has acquired the necessary knowledge and title to be admitted to the practice of dental surgery, and to the exercise of the said profession;

That the Board of Governors of the College of Dental Surgeons of the Province of Quebec, on the 10th of December, 1923, consented to the passing of an act to authorize the College of Dental Surgeons of the Province of Quebec to permit him to practise his profession of dental surgery in the Province of Quebec after undergoing an examination for the admission to practice but without an examination for the admission to study;

Whereas he has prayed for the passing of an act to that effect and it is expedient to grant his prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

J. C. Flanagan admitted to practice, after examination for practice but not for study.

**1.** The College of Dental Surgeons of the Province of Quebec is authorized to admit the said J. Cyril Flanagan among its members, and to grant him the license required for the Province of Quebec to permit him to practise the profession of dentist in this Province, after examination for admission to practice, but without examination for admission to study.

Coming into force.

**2.** This act shall come into force on the day of its sanction.

## CHAP. 162

An Act to authorize the College of Dental Surgeons of this Province to admit Dr. Arthur L'Heureux to the practice of dentistry, after final examination

[Assented to, the 15th of March, 1924]

Preamble.

**W**HEREAS Arthur L'Heureux, Doctor of Dental Surgery, graduate of the "Chicago College Art Dental Surgery University" of Chicago, Illinois, U. S. A., has, by his petition, represented:

That he was formerly of Chicago, and is now residing in the city of Montreal;

That he received his degree as Doctor of Dental Surgery on the 5th of June, 1923;
