

## C H A P. 15

An Act to amend the Revised Statutes, 1909, respecting the creation of the registration division of La Tuque

[Assented to, the 29th of December, 1922]

**HIS MAJESTY**, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

"Registration division of La Tuque."

**1.** On and after the day to be fixed by the proclamation mentioned in section 2 of this act, the territory mentioned in paragraph D of the annex to section 7 of this act, shall be detached from the registration division of Champlain, and shall form a separate registration division under the name of the "registration division of La Tuque".

Proclamation creating registration division.

**2.** As soon as the Lieutenant-Governor in Council shall have ascertained to his satisfaction that premises suitable for a registry office, with a fire-proof vault, have been placed at the disposal of the Government by the authorities of the town of La Tuque, he may issue a proclamation in the *Quebec Official Gazette* creating the registration division of La Tuque with a registry office at La Tuque, and appoint a registrar for such division.

Appointment of registrar.

Powers and obligations.

**3.** The powers vested in the county councils and the obligations to which the latter are bound under the provisions of articles 357, paragraph *a*, and 423 of the Municipal Code respecting registry offices, shall be vested in the town of La Tuque, in so far as the registry office of La Tuque is concerned, and the said provisions shall apply thereto, *mutatis mutandis*.

Contribution of municipalities to expenses of this act.

**4.** The town of La Tuque is authorized to conclude arrangements with the municipalities, situated wholly or in part within the boundaries of the registration division of La Tuque, respecting the contribution of such municipalities to the expenses incurred through this act, and such municipalities are also authorized to make the contribution fixed by the interested parties.

Laws applicable to the registration division.

**5.** All laws in force respecting the registration of various titles and deeds and all matters connected therewith, as well as those respecting registry offices and the registrars and deputy-registrars appointed thereto, shall apply to the registration division established by this act, except in so far as they may be inconsistent with its provisions.

**6.** The registry office and the chief place of the registration division of La Tuque shall be in the town of La Tuque. Registry office and chief place.

**7.** From and after the day fixed in the proclamation mentioned in section 2, the provisions referred to in the following annex, shall be enacted, amended or repealed, to the extent in such annex mentioned. Effect of proclamation on certain provisions.

### ANNEX

## CHAP. 16

An Act respecting the changing of the chief place of the
