

"29.—(Article 2668s.)

"Oath of Elector unable to mark his Ballot

"You swear (or solemnly affirm) that you are unable to read and to understand the ballot so as to mark it (or that you are incapacitated by blindness or other physical cause, as the case may be, from voting) without assistance. So help you God."

6. Article 2870 of the Revised Statutes, 1909, as amended by the act 10 George V, chapter 34, section 4, is again amended by replacing the first paragraph thereof by the following:

"2870. The service prescribed by article 2869 shall be effected, as respects ratepayers residing in the municipality, by leaving a copy of the special notice with the person to whom it is addressed, in person, or with a reasonable person at his domicile or place of business, or by leaving a copy thereof at the post office of the locality in a sealed and registered envelope addressed to the person to whom such notice must be given."

CHAP. 42

An Act to amend Acts respecting the Board of Roman Catholic School Commissioners of the City of Quebec.

[Assented to, the 29th of December, 1922]

WHEREAS the Board of Roman Catholic School Commissioners of the City of Quebec has, by its petition, represented:

Preamble.

That it is necessary for the Board of Roman Catholic School Commissioners of the city of Quebec to contract new loans for the purpose of erecting new school-houses, for providing furniture for them, and for completing the present school-houses generally;

And whereas it is expedient to grant the prayer of the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Issue of bonds, for certain purposes, authorized. **"1.** The Roman Catholic Board of School Commissioners of the City of Quebec, notwithstanding the provisions to the contrary contained in section 35 of the act 32 Victoria, chapter 16, may, for the purpose of building, enlarging and improving school-houses in the city of Quebec, issue, from time to time, according to the needs of the board, bonds redeemable in not more than fifty years, by annuities or semi-annuities or in any other manner which it may deem advisable, provided the whole amount of the said debt shall not exceed three million five hundred thousand dollars.

Proviso. Nevertheless the said commissioners may, in any other way, temporarily borrow any part of the amount above authorized, provided it does not exceed one hundred thousand dollars."

Coming into force. **2.** This act shall come into force on the day of its sanction.

CHAP. 43

An Act respecting the Protestant Board of School Commissioners of the City of Montreal and the Montreal Catholic School Commission

[Assented to, the 29th of December, 1922]

Preamble. **WHEREAS** the Protestant Board of School Commissioners of the City of Montreal and the Montreal Catholic School Commission have, by their petition, represented that the passing of a bill submitted to this Legislature by the Protestant Board of School Commissioners of the City of Montreal will entail a marked decrease in the revenues of the Montreal Catholic School Commission, without, on the other hand, sufficiently increasing the revenues of the Protestant Board of School Commissioners of the City of Montreal;

Whereas it is necessary, in order that they may be enabled to maintain and properly conduct the schools under their charge, that their revenue be increased;

Whereas it is expedient to grant the petition herewith
