An Act to incorporate the Montefiore Hebrew Orphans
Home of Montreal

[Assented to, the 29th of December, 1922]

WHEREAS Julius B. Miller, merchant; Asher Cooper, Preamble.
merchant; Moses Feldman, merchant; Robert Grading-
dinger, merchant; Nathan Blau, fur manufacturer; Hiram

of Montreal, have, by petition, set forth that they are
residents of the city of Montreal, and professing the Jewish
faith; and that a Jewish charitable institution to be used
as a home for children who may be deprived of their natural
protectors, either by death, or abandonment or otherwise,
belonging to the Hebrew faith, and for the purpose of
protecting such children, is at the present time urgently
needed in the city of Montreal; and that they are desirous
of being incorporated as a body politic and corporate under
the name of the "Montefiore Hebrew Orphans Home of
Montreal"; and

Whereas it is expedient to grant their prayer;

Therefore, His Majesty, with the advice and consent of
the Legislative Council and of the Legislative Assembly of
Quebec, enacts as follows:

members, are hereby constituted a corporation under the
name of the "Montefiore Hebrew Orphans Home of Mont-
real".

2. All property, moveable and immoveable, now pos- Property
sessed or held in trust for the said corporation shall be and held in trust
for the corp.

transferred to it. is hereby transferred to and vested in the said corporation and the said corporation shall have, hold, and exercise all rights belonging to the said corporation and shall be subject to all liabilities and obligations contracted by it.

Common seal, etc.

3. The said corporation may, under that name, possess a common seal with power to alter, change and renew the same and have perpetual succession, and shall have all rights incidental to corporations generally and all the powers hereby granted.

General powers.

4. The said corporation may at all times acquire, sell, transfer, lease, exchange, hypothecate, and alienate its immoveable property and the said corporation shall have the power to make, draw, accept, endorse and transfer bills of exchange, promissory notes, cheques, bonds and other negotiable documents and instruments under the signature of its officers and others in its corporate name as shall be determined by the by-laws of the said corporation.

Idem.

5. The said corporation may have, hold, sell, possess, erect and acquire by gift, purchase, will, or otherwise, any immoveable property in and near the city of Montreal that may be required, and may acquire, lease, erect, alter or exchange suitable buildings, and maintain, alter or renew the same as may be required for its purposes and for the proper carrying out of the objects of the corporation, provided always that the annual value of the immoveable property held by the said corporation shall not exceed the sum of twenty thousand dollars.

Property in excess of what corporation is authorized to possess.

6. In the event of the said corporation acquiring or receiving by gift or will or otherwise any immoveable property in excess of that which it is hereby authorized to possess, the said gift or legacy or other acquisition shall not on that account be void, but the said corporation shall be bound, within five years from the date of its entering into peaceable possession of the said gift or legacy or acquisition, to sell and dispose of the said immoveable property or part of it or some other of its immoveable property or part of it in such a manner that the immoveable property of the said corporation shall not exceed in annual value the sum of twenty thousand dollars.

By-laws, etc.

7. The said corporation shall be authorized to make by-laws, rules and regulations for its internal government and for the government and discipline of its officers and members and for the supervision of its affairs,—such officers

to be elected as may be provided for by the said by-laws, rules and regulations, and the mode, time of election, number and qualifications of its officers to be also determined by the said by-laws, rules and regulations—, and to amend or repeal the said by-laws, rules and regulations, provided always that none of the said by-laws, rules and regulations be inconsistent with this act or with the laws of this Province.

8. The said corporation, acting through its officers shall also be authorized to make and establish such rules and regulations as shall be deemed necessary or useful for the management, regulation and control of the said institution, and for the management, regulation and control of its agents, employees and servants, and for the appointment or removal of its agents, employees and servants and their wages or allowances, and also to make and establish rules and regulations for the admission, care and discharge and discipline of its inmates, and to amend or repeal the said rules and regulations and to exercise such powers as may be necessary for the proper control and government of the said institution, provided always that nothing in the said rules and regulations be inconsistent with this act or with the laws of this Province.

Regulations, etc., for the management, etc., of the institution, etc.

9. The said corporation shall have the power to collect and enforce, by suit at law or other legal proceedings, the payment of all subscriptions, donations, membership dues and other fees or instalments on the same.

Collection of subscriptions, etc.

10. All and every the funds and property of the said corporation shall be appropriated and applied solely for the purposes of the said corporation and for the payment of all such outlays and expenditures as may legitimately be incurred in connection therewith, and for the proper carrying out of the objects contemplated.

Expenditures, etc.

11. None of the officers or members of the said corporation shall be liable or responsible for the debts of the said corporation.

No personal responsibility for officers.

12. Nothing in this act shall prevent the provisions of the charter of the city of Montreal or of the by-laws passed by the said city in accordance with its charter from applying to the provisions of this corporation, nor the provisions of the law governing public health.

Provisions applicable.

13. The said corporation shall be bound to transmit to

the Lieutenant-Governor in Council a statement of its moveable and immoveable property and a statement of its affairs, and of the names of its officers, whenever required to do so.

Coming into
force.

14. This act shall come into force on the day of its sanction.

CHAP. 123

An Act to incorporate the "Congregation Beth Yitzchok"

[Assented to, the 29th of December, 1922]

Preamble.

WHEREAS Myer Strudensky, David Novek, Zalman Wachman, Abraham Luterman, Samuel Schwisberg, Fishel Shneeberg, Lezer Grosser, Mates Herscovici, Abraham Neamtan, Samuel Ianos, Isak Perlman, Max Bacher, David Ticker, Keihos Frank, Ben Litwin, Mates Maldovsky, Samuel Schreiber, Zisse Miller, Michel Dubrofsky, Simon Veriblofsky and Zachary Hirsbein, all merchants of the city and district of Montreal, have by petition represented that they belong to the Jewish religion and are adherents thereof, and that for the purpose of Divine worship according to the tenets of the Jewish religion, it is expedient and in the interest of the petitioners that they should be incorporated in order that the corporation so formed, may, in its own name, acquire and possess property, moveable and immoveable, and do all acts that may be required for the purposes of its formation; and whereas it is expedient to grant this prayer;

Therefore His Majesty with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:
