

university of this Province and that he should have completed three years of clerkship, computed from the 10th of December, 1921, in an advocate's office;

Whereas it is expedient to grant such petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** The Bar of the Province of Quebec is hereby authorized to permit the said Frank Bernard Chauvin to present himself for examination for admission to the practice of law as soon as he shall have obtained a degree in law from a duly recognized university of this Province and shall have completed three years of clerkship in an advocate's office, computed from the 10th day of December, 1921, and, upon the successful passing of such examination, to permit the said Frank Bernard Chauvin to practise as an advocate.

F. B. Chauvin admitted to the practice of law after formalities.

**2.** This act shall come into force on the day of its sanction.

#### C H A P. 135

An Act to authorize the Bar of the Province of Quebec to admit Raoul Gagnon to the practice of the legal profession

[Assented to, the 29th of December, 1922]

**W**HEREAS Raoul Gagnon, of Jonquières, county of Preamble.

Chicoutimi, has, by petition, set forth, that he was admitted to the study of the notarial profession in July, 1920, as a bachelor of arts;

That on the 13th of July, 1920, he was indentured as a notarial student with Arthur Duval, of Quebec, notary;

That he now wishes to study law;

That on the 13th of September, 1920, he began following the law course at Laval University, which he has continuously followed since;

That both his studies and the course followed by him at the University are identical with those required for the admission to the practice of law;

That he was indentured to Maurice Boisvert, of the city of Quebec, advocate;

That on the 28th of September, 1922, the General Council of the Bar gave its approval to the passing of this act;

And whereas the petitioner has prayed that an act be passed for the aforesaid purposes, and it is expedient to grant his prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Admission of Raoul Gagnon to examination. **1.** The Bar of the Province of Quebec is authorized to admit Raoul Gagnon to the examination for the practice of law after studying for three years from the date of his admission to the study of the notarial profession.

Admission of Raoul Gagnon to the practice of law. **2.** The Bar of the Province of Quebec is authorized to admit him among its members and allow him to practise law immediately after examination, provided that he complete his clerkship in a law office and obtain a degree in law from Laval University.

Coming into force. **3.** This act shall come into force on the day of its sanction.

#### CHAP. 136

An Act to regularize the clerkship of Armand Bélanger

[Assented to, the 29th of December, 1922]

Preamble. **W**HEREAS Armand Bélanger, of the city of Outremont, notarial student, has, by petition, represented: That he has continuously attended at the office of his father, Léandre Bélanger, notary, residing at Outremont, but practising in the city of Montreal, since the 14th of July, 1920;

That the act of indenture required by article 4786 of the Revised Statutes, 1909, was only passed with his father, the said Léandre Bélanger, on the 26th of September, 1922, before Adrien Bélanger, notary, and registered with the secretary of the Board of Notaries of the district of Montreal, on the 28th of September, 1922;

That he was admitted to the study of the notarial profession by the Board of Notaries of the Province of Quebec, at its sitting of the 29th of September, 1922;

That if he were admitted to the practice of the notarial profession by the Board of Notaries, he would be unable to practise before the 28th of September, 1925;

That it is desirable that the date of his clerkship should be considered as of the 14th of July, 1920;

That the Board of Notaries of the Province of Quebec, at its sitting of the 29th of September, 1922, gave its assent to the passing of an act for this purpose;
