

And whereas the petitioner has prayed that an act be passed for the aforesaid purposes, and it is expedient to grant his prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Admission

1. The Bar of the Province of Quebec is authorized to admit Raoul Gagnon to the examination for the practice of law after studying for three years from the date of his admission to the study of the notarial profession.

2. The Bar of the Province of Quebec is authorized to admit him among its members and allow him to practise law immediately after examination, provided that he complete his clerkship in a law office and obtain a degree in law from Laval University.

3. This act shall come into force on the day of its sanction.

CHAP. 136

An Act to regularize the clerkship of Armand Bélanger

[Assented to, the 29th of December, 1922]

Preamble.

WHEREAS Armand Bélanger, of the city of Outremont, notarial student, has, by petition, represented: That he has continuously attended at the office of his father, Léandre Bélanger, notary, residing at Outremont, but practising in the city of Montreal, since the 14th of July, 1920;

That the act of indenture required by article 4786 of the Revised Statutes, 1909, was only passed with his father, the said Léandre Bélanger, on the 26th of September, 1922, before Adrien Bélanger, notary, and registered with the secretary of the Board of Notaries of the district of Montreal, on the 28th of September, 1922;

That he was admitted to the study of the notarial profession by the Board of Notaries of the Province of Quebec, at its sitting of the 29th of September, 1922;

That if he were admitted to the practice of the notarial profession by the Board of Notaries, he would be unable to practise before the 28th of September, 1925;

That it is desirable that the date of his clerkship should be considered as of the 14th of July, 1920;

That the Board of Notaries of the Province of Quebec, at its sitting of the 29th of September, 1922, gave its assent to the passing of an act for this purpose;

Whereas it is expedient to grant his petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly, enacts as follows:

1. The clerkship of Armand Bélanger, of the city of Outremont, notarial student, shall be dated as of the 14th of July, 1920, notwithstanding the fact that his indenture of clerkship was only signed on the 26th of September, 1922, and registered with the secretary of the Board of Notaries two days thereafter.

2. This act shall come into force on the day of its sanction.

CHAP. 137

An Act to authorize the College of Physicians and Surgeons of the Province of Quebec to admit Jean Baptiste Delâge to the practice of medicine and surgery, after examination

[Assented to, the 29th of December, 1922]

WHEREAS Jean Baptiste Delâge, of the city and district of Montreal, has, by his petition, represented:

That in the month of September, 1914, he was admitted as a student of medicine and surgery in Laval University, of Montreal, and that he followed the lectures in medicine and surgery in the said university during the prescribed five years;

That in the month of June, 1919, the said university granted him a diploma of doctor of medicine;

That by inadvertence and for other grave reasons, he did not obtain from the College of Physicians and Surgeons of the Province of Quebec the certificate authorizing him to study medicine;

That from the year 1919, he has regularly and continuously acted as house doctor in different hospitals of Montreal;

That in view of the foregoing, the College of Physicians and Surgeons of the Province of Quebec has given its approval to the presenting of a bill authorizing the petitioner to practise medicine after having undergone the examination required for the license before the board of examiners of the said College;

Whereas the petitioner has prayed that an act be
