

C H A P. 9

An Act to ratify the contract between the Government of the Province of Quebec and l'*Hôpital Laval*, respecting the administration of the Sanatorium of *Lac Edouard*

[Assented to, 8th of March, 1922]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The contract between the Government of the Province of Quebec and l'*Hôpital Laval*, entered into the 20th day of October, 1921, before Charles Delagrave, Notary, under the number 4740 of his minutes, and reproduced as an annex to this act, is ratified.

2. This act shall come into force on the day of its sanction.

 ANNEX

On the twentieth day of October, one thousand nine hundred and twenty-one.

BEFORE CHARLES DELAGRAVE, Notary for the Province of Quebec, residing and practising at Quebec,

CAME AND APPEARED

HIS MAJESTY THE KING GEORGE V, represented and acting herein by the Honourable **LOUIS ATHANASE DAVID**, herein acting in his quality of Secretary of the Province of Quebec, authorized for the purposes of these presents under an order-in-council dated at Quebec on the twentieth day of September last (1921), and approved by His Honour the Lieutenant-Governor on the twenty-fourth following,

Party of the first part;

hereinafter called "The Government."

AND

L'HÔPITAL LAVAL, a body politic and corporate having its principal place of business in the city of Quebec,

herein represented and acting by Mr. J. Arthur Larue, of Quebec, chartered accountant, its treasurer, duly authorized,

Party of the second part;

hereinafter called "L'Hôpital Laval."

Which said parties, whereas the Government of the Province has acquired the ownership of the Sanatorium of *Lac Edouard* and desire to entrust the management thereof to *l'Hôpital Laval*, covenant between them as follows:

1. The Government obliges itself to repair and arrange the immoveable property and buildings constituting the Sanatorium of *Lac Edouard*, so that the premises may be ready to receive, if required, seventy-five tubercular patients.

2. *L'Hôpital Laval* obliges itself:

a. To receive in the said sanatorium tubercular patients to the number of seventy-five (75) and to provide them with the proper care, upon the payment of the value of the board by those who are in a position, wholly or partly, so to do;

b. To assume all the costs of administration of the said sanatorium, including therein the fees of doctors, nurses, and others, and shall have the sole control of the management of the sanatorium; but the Government shall have the right to verify by its inspector or inspectors the condition in which the sanatorium may be kept;

c. To keep, for all matters concerning the Sanatorium of *Lac Edouard*, separate accounts and to report to the Government the condition of receipts and disbursements having relation to the maintenance of the said sanatorium.

PRICE

3. To aid in the meeting of the necessary expenses for the care to be given to poor patients, the Government shall pay to *l'Hôpital Laval* the sum of fifteen hundred dollars (\$1,500.00) per month, in advance, starting from the date on which *l'Hôpital* takes charge of the said sanatorium.

4. No rent shall be claimed by the Government for the use and occupation by *l'Hôpital Laval* of the moveable and immoveable property now serving, or that will in future serve, the purposes of the said sanatorium.

TERM

5. The present contract is made for one year starting

from the first of September last (1921) and shall be renewed from year to year, unless one of the parties, four months before the first of August, give written notice to the other party that it intends to terminate such contract at the expiration of the year then current.
