## C H A P. 17

An Act to detach certain lots from the county of Kamouraska and to annex them to the parish of St. Pierre d'Estecourt, in the county of Temiscouata, for electoral, judicial, municipal, school and registration purposes

**H**IS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** Paragraph 26 of article 67 of the Revised Statutes, R. S., 67, § 26, am.

**1.** Paragraph 29 of article 67 of the Revised Statutes, 1909, is amended by replacing the words: "and St. Lin," in the twelfth line of the second paragraph of the description of the territory included therein, by the words: "St. Lin, and lots Nos. 467 to 509, and the portion of lot No. 510 which crosses lots Nos. 467, 470, 473, 481, 480, 478, 488, 489, 492, 494, 495 and 499, of the cadastre of the parish of Ste. Anne des Plaines, in the county of Terrebonne, now forming part of the recently erected municipality of the parish of St. Joachim,".
