

"46b | Montreal-St-Louis. . | This county,—which comprises, in the city of Montreal, St. Louis ward, and that part of St. Jean-Baptiste ward which extends towards the north as far as the middle of Mount-Royal street, towards the east as far as St. Lawrence Boulevard, inclusively, towards the west as far as Esplanade street,—is bounded by Centre ward, St. Lawrence ward, that part of St. Jean-Baptiste ward situated to the east of St. Lawrence street, and St. James and East wards, as they were bounded on the 3rd day of April, 1912, respectively."

Coming into force. **3.** This act shall come into force on the day of its sanction.

C H A P. 20

An Act to amend the law establishing a new judicial district with its chief place at Amos.

[Assented to, 8th of March, 1922]

Preamble.

WHEREAS in virtue of the provisions of the act 11 George V, chapter 13, the court house and goal of the new judicial district of Abitibi have been built in the village of Amos, according to the plans and specifications prepared by the Minister of Public Works and Labour, and carried out under the supervision of the Department of Public Works and Labour, on the property described as being "the western half of the lot, number 21 of the village of Amos";

Whereas the municipal corporation of the village of Amos is willing to convey gratuitously to the Government the ownership of the said land, but it has not the necessary authority according to law to make such transfer;

Whereas it is expedient to authorize the said municipality to transfer gratuitously to the Government of this Province the immoveable property above described;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

11 Geo. V, c. 13, s. 7a enacted. **1.** The act 11 George V, chapter 13, is amended by inserting therein, after article 7 thereof, the following:

Gratuitous **"7a.** The municipal corporation of the village of Amos

may, notwithstanding any law to the contrary, transfer gratuitously to the Government of the Province of Quebec the ownership of the following immovable property: the western half of the lot number 21 of the village of Amos, by a mere resolution of its council authorizing the mayor and the secretary-treasurer of the municipality to enter into a contract in its name for this purpose with the Minister of Public Works and Labour representing the Government of this Province."

2. This act shall come into force on the day of its sanction. Coming into force.

CHAP. 21.

An Act respecting the changing of the chief place of the judicial district of Terrebonne

[Assented to, 21st of March, 1922]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The Lieutenant-Governor in Council may cause to be built a court house and a suitable gaol for the district of Terrebonne, in the town of St. Jérôme, on the site which he may choose, after the payment to the Provincial Treasurer of the contribution to which the county municipality of Terrebonne is liable under section 3. Construction of court house and gaol authorized for district of Terrebonne.

2. Such court house and gaol shall contain sufficient rooms for the administration of justice and for necessary public offices. The court house must also contain fire-proof vaults fitted so as to hold all the documents. Requirements imposed.

Such buildings shall be built under the direction of the Minister of Public Works and Labour, in accordance with plans and specifications approved by the Lieutenant-Governor in Council. Direction and approval of construction.

The cost of building such court house and gaol, including the purchase of the necessary sites, shall not exceed the sum of two hundred thousand dollars. Total cost authorized.

3. To assist in the construction of the said court house and gaol, the municipality of the county of Terrebonne is authorized to subscribe, by mere resolution, and it undertakes to subscribe, and to pay over to the Provincial Treasurer, an amount of fifty thousand dollars. Subscription by the county municipality of Terrebonne.
