

## C H A P. 48

An Act to amend the act 7 George V, chapter 28 respecting the Montreal Catholic School Commission

[Assented to, 21st of March, 1922]

**W**HEREAS the Montreal Catholic School Commission Preamble. has, by its petition, represented:

That it is necessary for it to acquire new sites for schools; to acquire and build new schools; to enlarge and to improve schools already existing; build residences for its staff of religious teachers; and, to that end, to effect loans not exceeding two million three hundred thousand dollars;

That it is in the public interest to authorize the appropriation of properties, whether built upon or vacant, for all school purposes and to amend to that effect article 2751 of the Revised Statutes, 1909, and section 2 of the act 1 George V (2nd session), chapter 29;

That it is expedient to annex that part of the territory of the school municipality of Côte Saint Luc now situated within the limits of the city of Montreal;

Whereas it is expedient to grant the request of the Montreal Catholic School Commission, and to grant it the powers it asks for and to amend, among others, the act 7 George V, chapter 28 governing the said commission;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** Section 1 of the act 54 Victoria, chapter 53, as <sup>54 Viet., c.</sup> amended by the acts 63 Victoria, chapter 99, section 1; <sup>53, s. 1, am.</sup> 5 Edward VII, chapter 90, section 1; 6 Edward VII, chapter 84, section 1; 9 Edward VII, chapter 39, section 1; 1 George V (1st session), chapter 22, section 1; 2 George V, chapter 27, section 1; 3 George V, chapter 30, section 1; 6 George V, chapter 63, section 1; 8 George V, chapter 37, sections 1 and 2; 10 George V, chapter 39, section 3, and 11 George V, chapter 49, section 1, is again amended by adding the following sub-section thereto:

“y. The Montreal Catholic School Commission is, how- Additional ever, authorized to issue, in addition to the loans already bond issue. effected by it or already authorized, bonds or debentures for an additional amount not exceeding two million three hundred thousand dollars, for the purpose of enlarging and improving the schools already existing, of acquiring new school sites and of building new schools and residences for its staff of religious teachers.”

7 Geo. V, c. 28, s. 2, am. **2.** Section 2 of the act 7 George V, chapter 28, is amended by adding the following paragraph:

Extension of territory jurisdiction. "Nevertheless, that part of the territory of the school municipality of Côte Saint Luc, comprising lots numbers 143, 148, 152*a*, 154, 164, 176, 176*a* and 176*b* of the parish of Montreal, situate in the limits of the city of Montreal, is declared to have formed part of the territory of the Montreal Catholic School Commission for all legal purposes since the 1st July, 1917."

7 Geo. V, c. 28, s. 31, am. **3.** Section 31 of the act 7 George V, chapter 28, is amended by adding thereto the following:

Fees of chairman of central board. "The central board is authorized to pass by-laws respecting the fees to be paid to the chairman of the central board, to fix the amount and determine the manner in which they shall be paid, provided the total amount of fees shall not exceed fourteen hundred dollars a year."

Coming into force. **4.** This act shall come into force on the day of its sanction.

## C H A P. 49

### An Act respecting the Protestant Board of School Commissioners of the city of Montreal

[Assented to, 8th of March, 1922]

Preamble. **W**HEREAS the Protestant Board of School Commissioners of the City of Montreal have, by their petition, represented that it is expedient that legislation should be enacted authorizing the said board to issue additional bonds or debentures, to regulate the amount thereof and the manner of such issue; and

Whereas it is expedient to grant the prayer of the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Additional bond issue. **1.** The Protestant Board of School Commissioners of the City of Montreal are hereby authorized and empowered to issue additional bonds or debentures to an amount not exceeding one million five hundred thousand dollars, the said bonds or debentures to be payable as to principal in thirty years from date of issue, and to bear interest at a rate not exceeding six per centum
