

C H A P. 60

An Act to amend the Revised Statutes, 1909, respecting
the holding of terms of the Circuit Court

[Assented to, the 8th of March, 1922]

HIS MAJESTY, with the advice and consent of the
Legislative Council and of the Legislative Assembly
of Quebec, enacts as follows:

1. The Revised Statutes, 1909, are amended by in-^{R. S., 3123a,}
serting therein, after article 3123 thereof, the following ^{enacted.}
article:

“**3123a.** Notwithstanding the provisions of article ^{Term days}
3120, the Lieutenant-Governor may, by proclamation, ^{in certain}
order that every juridical day shall be a term day, in the ^{districts.}
district or districts falling under article 3120 and men-
tioned in the proclamation, and may, in like manner, revoke
such order for one or more of such districts;—the whole ^{Provisions}
nevertheless subject to the provisions of article 15 of the ^{to apply.}
Code of Civil Procedure.”

2. This act shall come into force on the day which the ^{Coming into}
Lieutenant-Governor in Council may be pleased to fix by ^{force.}

C H A P. 61

An Act to amend the Revised Statutes, 1909, respecting
the appointment of Judges of the Sessions and
Police Magistrates

[Assented to, 21st of March, 1922]

HIS MAJESTY, with the advice and consent of the
Legislative Council and of the Legislative Assembly
of Quebec, enacts as follows:

1. Article 3260 of the Revised Statutes, 1909, as amend-^{R. S., 3260,}
ed by the acts 5 George V, chapter 52, section 1, and 11 ^{am.}
George V, chapter 62, section 1, is again amended by
replacing the word: “ten”, in the fourth line thereof, by
the word: “five”.

2. Article 3282 of the Revised Statutes, 1909, as ^{Id., 3282,}
amended by the act 4 George V, chapter 36, section 2, ^{am.}

is again amended by inserting therein, after the word: "persons", in the second line thereof, the words: "who shall be advocates of at least five years' standing and who, when appointed, shall cease practising,".

Coming into force.

3. This act shall come into force on the day of its sanction.

C H A P. 62

An Act to amend the act respecting the Court of the Sessions of the Peace

[Assented to, 21st of March, 1922]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

R. S., 3262, replaced.

1. Article 3262 of the Revised Statutes, 1909, as amended by the acts 4 George V, chapter 36, section 1, and 5 George V, chapter 52, section 2, is replaced by the following:

Salaries of judges of the sessions.

"3262. The annual salary of each of the judges of the sessions, ordinarily discharging the duties of such office, shall not exceed six thousand dollars, and the salary, so fixed by the Lieutenant-Governor in Council, shall be payable out of the consolidated revenue fund of the Province; and each such judge shall perform the duties of judge of the sessions and license commissioner, as well as all other duties incumbent upon him, or which may be imposed upon him by any law in force in this Province."

Duties.

Coming into force.
