

## C H A P. 78

An Act to amend the Revised Statutes, 1909, respecting the College of Dental Surgeons of the Province of Quebec

[Assented to, 21st of March, 1922]

**HIS MAJESTY**, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

R. S., 5032, am. **1.** Article 5032 of the Revised Statutes, 1909, as amended by the act 10 George V, chapter 64, section 1, is again amended:

*a.* By replacing the word: "fifteen", in the first line thereof, by the word: "eleven".

*b.* By replacing the word: "twelve", in the fifth line thereof, by the word: "nine".

Id., 5045b and 5045c. enacted. **2.** The following articles are inserted in the Revised Statutes, 1909, after article 5045a, as enacted by the act 9 George V, chapter 56, section 1:

Final examination of students of dentistry. **"5045b.** Notwithstanding article 5045, the College of Dental Surgeons of the Province of Quebec shall permit its assessors to supervise, at the final examination, any person now admitted to the study of dentistry, registered before the 15th of October, 1921, as a student of dentistry, and who has commenced his course in a university legally recognized in the Province before the 15th of October, 1921.

When license and diploma granted. **"5045c.** Notwithstanding article 5045, the College of Dental Surgeons of the Province of Quebec shall grant them a license and diploma according to the provisions of article 5048, so soon as the four years of inscription by the College of Dental Surgeons of the Province of Quebec as a student in the art of dentistry shall have expired."

R. S., 5050, am. **3.** Article 5050 of the Revised Statutes, 1909, is amended:

*a.* By replacing the words: "the second Wednesday of September", in the third line thereof, by the words: "the first of September, or, if that day be a non-judicial day, the next following judicial day";

Advance of dates of examination. *b.* By adding, thereto, after paragraph 1 thereof, the following paragraph:

"Nevertheless, it shall be permissive to the Board of Governors, by by-law, to advance either the date fixed

for the examination for admission to study or for the examination to practice.”

**4.** Section 1 of this act shall come into force at the next general elections of the Board of Governors of the College of Dental Surgeons of the Province of Quebec; sections 2 and 3 of this act shall come into force on the day of its sanction. <sup>Coming into force.</sup>

## C H A P. 79

An Act to amend the Revised Statutes, 1909, respecting  
civil engineers

*Assented to, 21st of March, 1922]*

**HIS MAJESTY**, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** Article 5116 of the Revised Statutes, 1909, as amended by the act 10 George V, chapter 66, section 1, is again amended by replacing paragraph *c* thereof, by the following:

“*c.* The expression “member” means a member of the “Member.” said corporation.”

**2.** Article 5116*b* of the Revised Statutes, 1909, as enacted by the act 10 George V, chapter 66, section 2, is amended by replacing the words: “of the Engineering Institute of Canada, domiciled outside of the Province of Quebec,” in the eighth, ninth, and tenth lines of paragraph 2 thereof, by the following: “of any corporation or society of professional engineers of the other Provinces of Canada, provided such corporation or society exacts equivalent qualifications for the admission of its members and that it grants the same privileges to members of the corporation of this Province.”

**3.** Article 5117 of the Revised Statutes, 1909, as amended by the act 10 George V, chapter 66, section 3, is again amended by striking out paragraphs *b* and *c* thereof.

**4.** Article 5118 of the Revised Statutes, 1909, as amended by the act 10 George V, chapter 66, section 4, is again amended:

*a.* By replacing the first paragraph thereof, by the following:
