

C H A P. 102

An Act to amend the Municipal Code respecting motor vehicles on certain roads

[Assented to, the 21st of March, 1922]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. Article 453 of the Municipal Code, as amended by Mun. Code, the act 11 George V, chapter 107, section 1, is again art. 453, am. amended by inserting therein, after the second paragraph thereof, the following:

“It is not responsible for damages suffered by any person motoring on an earth road or a winter road.” Responsibility for damages.

2. Article 478 of the Municipal Code is amended by Mun. Code, inserting therein, after the first paragraph thereof, the art. 478, am. following:

“Motor vehicles travel at their own risk and peril on earth roads and winter roads.” Motor vehicles on earth and winter roads.

3. This act shall come into force on the day of its sanction. Coming into force.

C H A P. 103

An Act to amend article 460 of the Municipal Code

[Assented to, the 21st of March, 1922]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. Article 460 of the Municipal Code is amended by Mun. Code, inserting therein, after the second paragraph thereof, the art. 460, am. following paragraph:

“If the front road of two ranges in any part of its length is diverted, owing to natural obstacles, in such manner that the part of the road so diverted is no longer adjacent to the lots of one of the ranges, the council of the corporation may, by by-law or *procès-verbal*, declare that such part of the road, so diverted, is the front road of the two ranges and must be maintained by the owners of the Front road of two ranges where diverted.

lots of both ranges, in the proportion determined by the by-law or *procès-verbal*."

Coming into force.

2. This act shall come into force on the day of its sanction.

C H A P. 104

An Act to amend the charter of the City of Quebec

[Assented to, 21st of March, 1922]

Preamble.

WHEREAS the city of Quebec has, by its petition, represented that it is in the interest of the city and necessary to the proper administration of its affairs, that its charter, the act 29 Victoria, chapter 57 and all the acts amending the same be amended, and whereas it is expedient to grant its prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Amount of loan authorized for city of Quebec.

1. The city of Quebec is hereby authorized to borrow a sum not exceeding four hundred and ninety-five thousand four hundred and eighty-six dollars to pay the cost of the following:

How same to be employed.

- a. One hundred and twenty thousand dollars for permanent works by the waterworks department;
- b. Sixty-one thousand four hundred and eighty-six dollars to pay exchange on the last loan;
- c. Twenty-five thousand dollars for permanent sidewalks;
- d. Twenty-five thousand dollars for connecting, by means of a hill, St. Sauveur Ward to Mathieu street, in Montcalm Ward;
- e. Two hundred and sixty-four thousand dollars for paving streets in the following wards and for the amounts below mentioned:

Wards benefited by street paving.

Champlain Ward, thirty thousand dollars; St. Roch Ward, fifty-four thousand dollars; St. John Ward, forty-five thousand dollars; St. Sauveur Ward, fifty-five thousand dollars; Montcalm Ward, forty thousand dollars; Jacques-Cartier Ward, forty thousand dollars.

How loan to be effected.

2. To effect such loan, the city may issue bonds or registered stock certificates when it may deem the same necessary for the objects above mentioned; which bonds
