b. Lots detached from the parish of St. Joseph d'Alma, county of Lake St. John:—lots 32 to 42, inclusively, of the Saguenay range, township of Labarre; lots 26 to 37, inclusively, of ranges IX and X of the township of Labarre;

c. Lots detached from the parish of St. Bruno, county of Lake St. John:—lots 25 to 30, inclusively, of ranges I east, II east, III east of the township of Labarre; lots 3 to 25, inclusively, of range X of the township of Labarre.

Provisions applicable.

**3.** The municipality of the parish of Larouche shall be, except as hereinafter prescribed, subject to the provisions of the Municipal Code.

Ratepayers not liable for certain debts.

**4.** The ratepayers of the parish of Larouche shall not be liable for debts and obligations contracted, for the following purposes: waterworks, graveling, macadamising or stoning of roads, by the municipalities of which their properties formed part before the coming into force of this act.

Coming into force.

**5.** This act shall come into force on the day of its sanction.

## CHAP. 117

An Act to incorporate the municipality of the parish of Saint Joachim, in the county of l'Assomption

*Assented to, 21st of March, 1922]*

Preamble.

**W**HEREAS, Napoleon Gauthier, Joseph Meunier and several other ratepayers constituting the majority of the inhabitants of the parish of Saint Joachim, situate partly in the county of l'Assomption and partly in the county of Terrebonne, have, by their petition, asked that the said canonical parish be erected into a separate local municipality, and whereas it is expedient to grant such prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** The parish of Saint Joachim, as canonically erected, situated in the municipalities of Saint Lin de Lachenaye and Saint Henri de Mascouche, in the county of l'Assomption and in the municipality of Sainte Anne des Plaines, in the county of Terrebonne, shall in future constitute a local municipality, situate entirely in the county of l'Assomption, under the name of "The Municipality of the parish of Saint Joachim."

This territory shall be composed of the following lots: Territory

a. That part of the municipality of Saint Lin de Lachenaye, county of l'Assomption, consisting of lots numbers 115, 114, 113, 112, inclusively, the two latter being prolonged as far as the centre of the public road which borders on them and of lots 120 to 167, inclusively, of the official plan and book of reference of the said municipality;

b. That part of the municipality of the parish of Saint Henri de Mascouche, county of l'Assomption, consisting of lots numbers 921 to 996, inclusively, 1049 to 1099, inclusively, and 1100 to 1126, inclusively, of the official plan and book of reference of the said municipality;

c. That part of the parish of the municipality of Sainte Anne des Plaines, in the county of Terrebonne, consisting of lots numbers 467 to 509, and that part of lot No. 510 which crosses lots Nos. 467, 470, 473, 481, 480, 478, 488, 489, 492, 494, 495 and 499, inclusively, of the official plan and book of reference of the said municipality;

d. Of the emprise of the Laurentides railway and of the public roads to the extent that they serve the territory as above constituted.

**2.** The municipality of the parish of Saint Joachim shall be entirely situate in the county of l'Assomption, of which it shall form part for all electoral, municipal, judicial and registration purposes, and shall be governed by the Quebec Municipal Code, except in so far as the same may be inconsistent with this act.

**3.** The first election of the municipality shall be held in the month following the sanction of this act. It shall be presided over by a person chosen by the majority of the electors present at the meeting, and all the articles of the Quebec Municipal Code relating to municipal elections and meetings of electors shall apply, *mutatis mutandis*, to the first election of the mayor and councillors.

**4.** The valuation rolls of the said municipalities of Saint Lin de Lachenaye, of Saint Henri de Mascouche and of Sainte Anne des Plaines shall serve as a basis for electoral

qualifications of the municipal electors for the election mentioned in the foregoing section.

**5.** The valuation rolls, electoral lists, procès-verbaux, apportionments, by-laws and other documents governing the former territory hereby erected as a separate local municipality, shall continue to apply to such territory, until amended, repealed or replaced by competent authority, and certified copies of all such documents relating to the said municipality shall be legal and authentic and be proof of their contents for all lawful purposes.

Costs, etc

**6.** The costs, fees and disbursements incurred in connection with the passing of this act shall be paid by the municipality of the parish of Saint Joachim.

**7.** This act shall come into force on the day of its sanction.

#### C H A P. 118

An Act to detach certain lots of the second division of the county of Matane and annexing them to the parish of St. Octave de Métis-Sud in the first division of the said county of Matane.

[Assented to, 21st of March, 1922]

Preamble

**W**HEREAS Jean-Baptiste Bérubé, Philippe Bouchard, Joseph Dufour and Thomas Richard, all of the parish of St-Octave de Métis-Sud, farmers, have by their petition represented, that it is in the interest of the rate-payers of St. Octave de Métis-Sud and of those of St-Antoine de Padoue de Kempt that the territory hereinafter described be detached from the parish of St-Antoine de Padoue de Kempt, to be annexed to the said parish of St-Octave de Métis-Sud; and,

Whereas it is expedient to grant the prayer contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:
