**5.** The valuation rolls, electoral lists, procès-verbaux, apportionments, by-laws and other documents governing the former territory hereby erected as a separate local municipality, shall continue to apply to such territory, until amended, repealed or replaced by competent authority, and certified copies of all such documents relating to the said municipality shall be legal and authentic and be proof of their contents for all lawful purposes.

**6.** The costs, fees and disbursements incurred in connection with the passing of this act shall be paid by the municipality of the parish of Saint Joachim.

#### C H A P. 118

An Act to detach certain lots of the second division of the county of Matane and annexing them to the parish of St. Octave de Métis-Sud in the first division of the said county of Matane.

[Assented to, 21st of March, 1922]

Preamble

**W**HEREAS Jean-Baptiste Bérubé, Philippe Bouchard, Joseph Dufour and Thomas Richard, all of the parish of St-Octave de Métis-Sud, farmers, have by their petition represented, that it is in the interest of the rate-payers of St. Octave de Métis-Sud and of those of St-Antoine de Padoue de Kempt that the territory hereinafter described be detached from the parish of St-Antoine de Padoue de Kempt, to be annexed to the said parish of St-Octave de Métis-Sud; and,

Whereas it is expedient to grant the prayer contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** The following territory, situated in the parish of St-Antoine de Padoue de Kempt, in the second division of the county of Matane, and comprised in the following boundaries: on the north-west from lots number five

hundred and ninety-seven (597) to six hundred and fifty Padoue and four (654), inclusively, in the fourth range of the Seigniory; annexed to on the south-west, from lots number five hundred and sixty- parish of St five (565) to five hundred and eighty-one (581), inclusively, Octave de Métis-Sud in the range north-east of the Kempt road; on the south-east by lot number five hundred and sixty-four (564) in the range north-east of the Kempt road aforesaid, and lots number seven hundred and fifty-seven (757) and seven hundred and fifty-eight (758) in the sixth range; on the north-east, lot number six hundred and ninety-six (696) and six hundred and ninety-six-A (696-A); this territory contained in the boundaries above described, comprising lots from number six hundred and ninety-seven-A, (697-A) to seven hundred and fifty-six (756), inclusively, of the official cadastre of the parish of St-Octave de Métis in the fifth range of the Métis Seigniory, is detached from the said parish of St-Antoine de Padoue, in the second division of the county of Matane and annexed to the parish of St-Octave de Métis-Sud, in the first division of the county of Matane, for municipal purposes.

**2.** The costs, fees and any expenses incurred for the Costs, etc. passing of this act, shall be paid by the parish of St-Octave de Métis-Sud, as an ordinary debt incurred in the interest of the public.

**3.** This act shall come into force on the day of its Coming into sanction. force.

#### C H A P. 119

An Act to incorporate the municipality of the parish of Saint-Pierre d'Estcourt, in the county of Temiscouata.

**W**HEREAS Horace Beaupré, J. N. Ducharme, Pierre Preamble. Blier, Ferdinand Blier, and several other ratepayers residing in the parish of Saint-David d'Estcourt and Saint-Eleuthère, in the county of Temiscouata and in that of Kamouraska, have, by their petition, prayed for the erection, as a municipality, of a parish under the name of "Saint-Pierre d'Estcourt" of a certain part of a territory situate in the parishes of Saint-David d'Estcourt, in the county of Temiscouata and of Saint-Eleuthère, in the county of Kamouraska, and whereas it is expedient to grant their prayer;
